Before me, the undersigned authority in and for said County and State, this day personally appeared, J. F. Henshaw, J. W. Gray, H. B. Williamson, B. F. Giles, Morgan Quick, and J. E. Styles, who each first being duly sworn separately say: That they are resident citizens of Madison County, Alabama, residing in or near Gurley, Alabama. That within the last six days they viewed out the new road which had been opened by the Town of Gurley, on Jackson Street in said Town Eastward to the public highway running from Gurley to Faint Rock station and along by the right of way of the Southern Railway Company; that at several places along said new road they measured from the center of the tract of said Railway Company to the nearest point of said new road, and that at no point was said highway nearer than thirty feet to the center of said Railway tract, and that the center of said new road is in line with the center of the highway where the new road and highway join; and they measured from the center of the tract of said Railway to said highway at some four or five places and that the nearest point of said highway to the center of said Railway tract is thirty feet or more; that the Railway of said Railway Company in traversing through the Town of Gurley and for about a mile on each side thereof or more, runs practically East and West; that said Railway tract runs practically East from Gurley and on a straight line for about a mile; that there is a highway connecting Faint Rock in the County of Jackson, with Gurley, in the County of Madison; that this highway for about two miles immediately East of Gurley runs along the north side of said Railway practically paralleling the tract of said Railway, and within a short distance of said Railway, and for a distance of about one mile, is within thirty or forty feet of said Railway, and as said highway approaches the Town of Gurley and after it reaches a point about 300 yards west of the eastern corporate limits of the Town of Gurley, said highway turns at a right angle immediately north and at this turn or point is the place where the new road was opened
