Q: State whether or not he gave you any instructions as to the use of that money? A: None.

Q: Did he state for what purpose it was to be used? A: No.

Q: Where were you to go and what was to be done when you left Huntsville and when did you expect to return? A: I thought I would return as soon as I was well.

Q: State whether or not anything was said to you on that occasion which indicated that you were not to return? A: No, sir, nothing.

Q: State whether or not you had any information that your departure at that time was a breaking up of the home, and a final separation between you and the Complainant? A: I don't think so.

Q: When did you first learn that this bill would be ~~xxxxx~~ filed, if you had such information before it was filed? A: Sometime in August, 1915.

Q: Why did you remain away from June until August? A: I was ill with typhoid ~~xxxxx~~ fever.

Q: Did the complainant visit you during that period of time? A: No.

Q: Subsequent to your leaving Huntsville in June until you heard of the filing of this bill, what provision did the complainant make for your support and maintenance? A: Very little.

Q: Approximately, what amount in money? A: I suppose three hundred dollars a year would cover it.

Q: I mean what money did Doctor send you between June and August when you heard of this bill? A: He gave me \$50.00 on leaving here, and sent me \$50.00.

Q: What provision has he made for you since the filing of the bill? A: Well, he has given me \$200.00. Most of that has gone for medicine.

Q: What board are you required to pay? A: \$35.00 a month.

Q: State whether or not you visited Huntsville in company with your counsel on or about the 25th of October, 1915? A: I did.

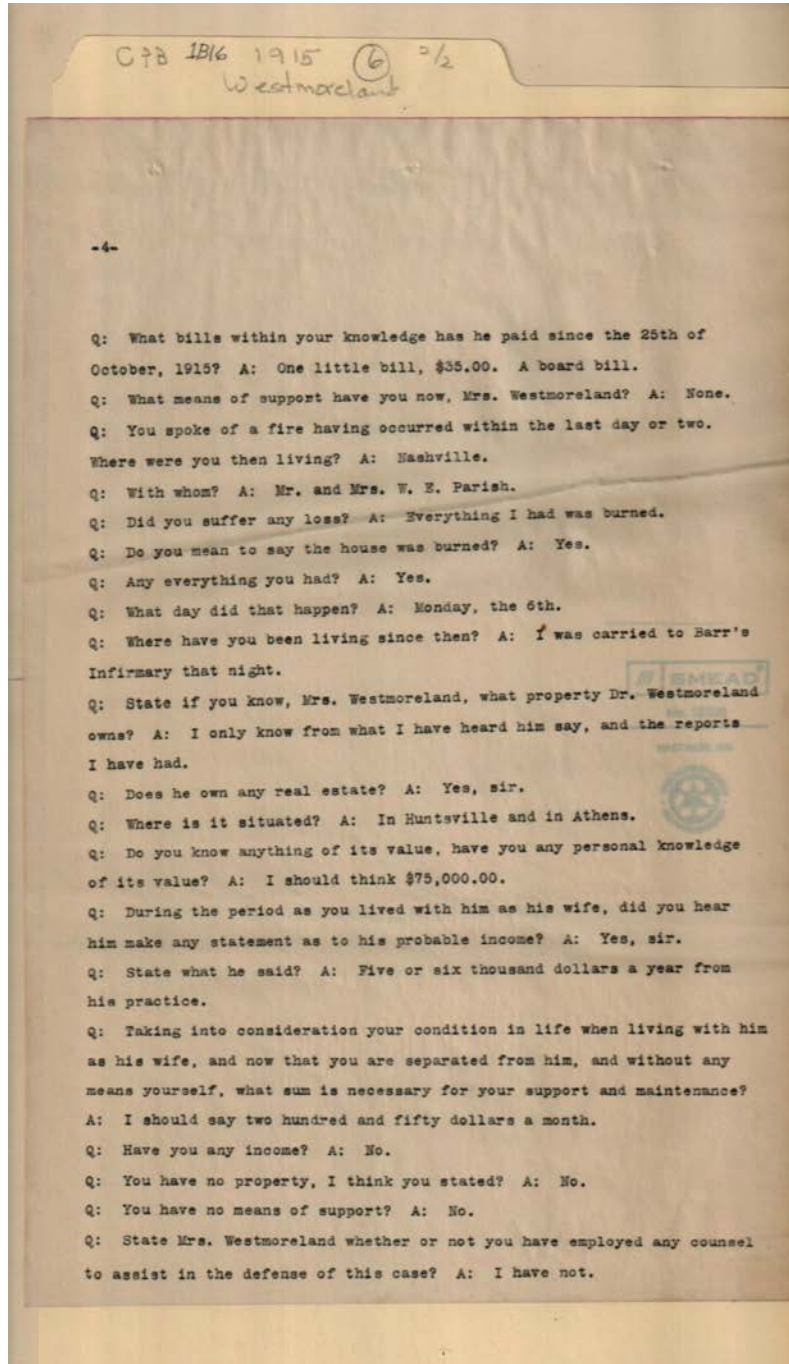

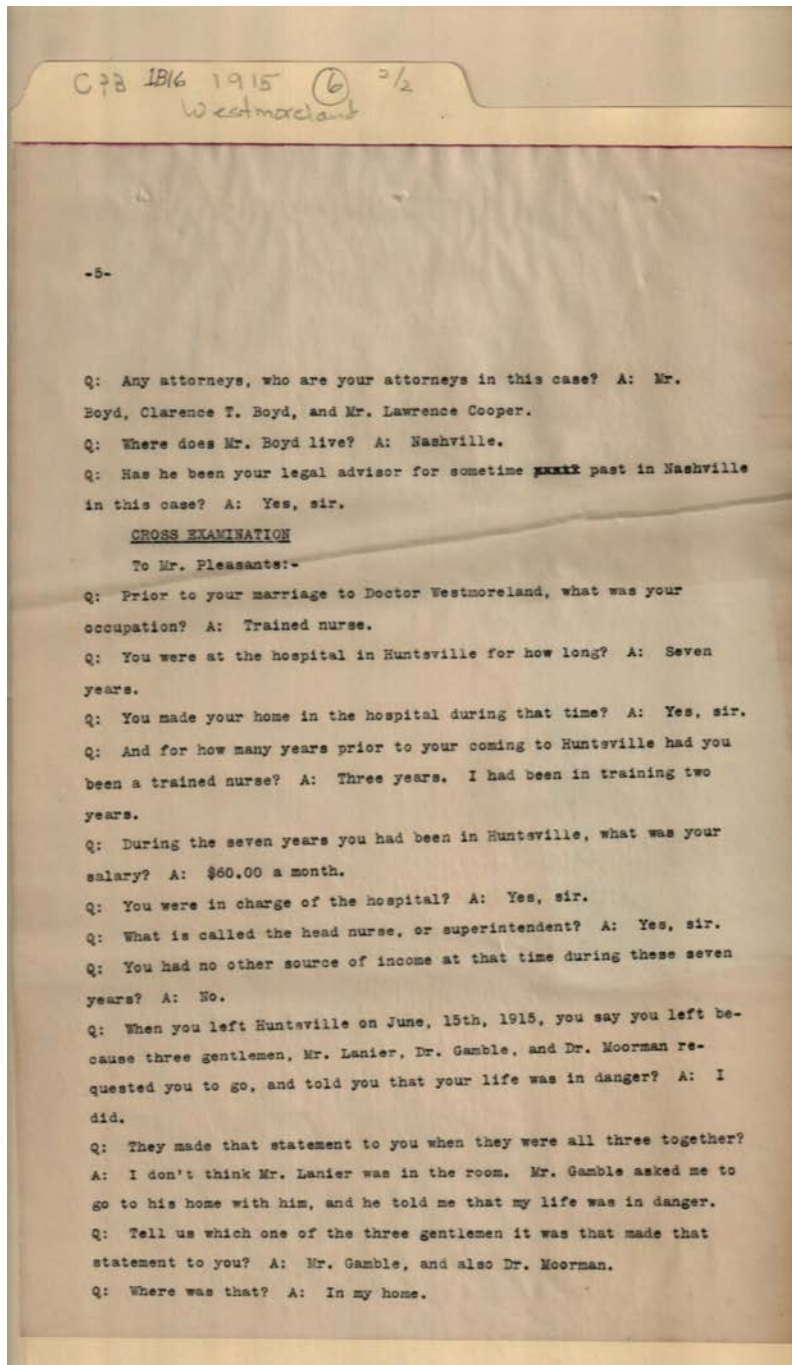

Q: And in Huntsville? A: Yes, sir.

Q: Do you know their ages? A: Yes.

Q: Give them? A: The girl is fourteen, I think. The boy is nine years old in May.

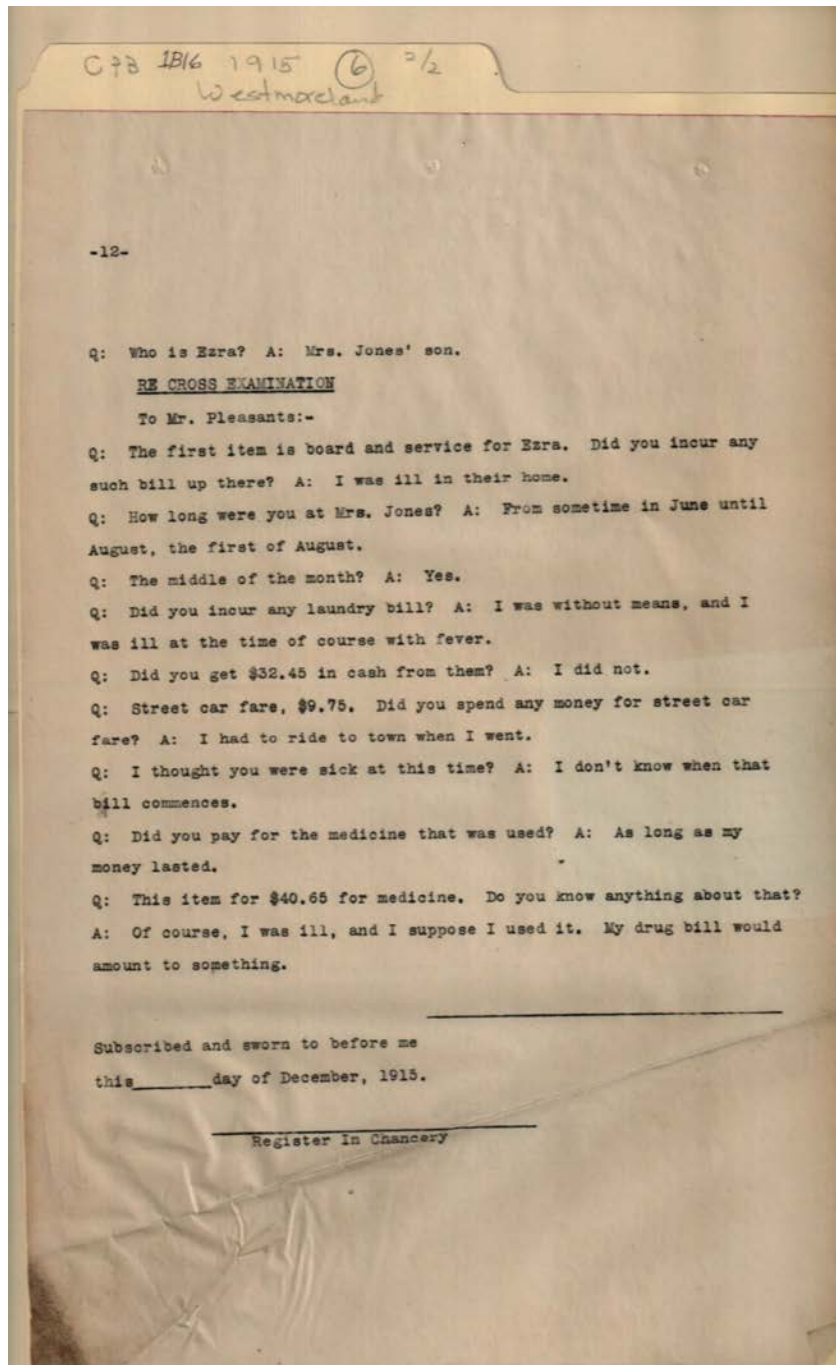

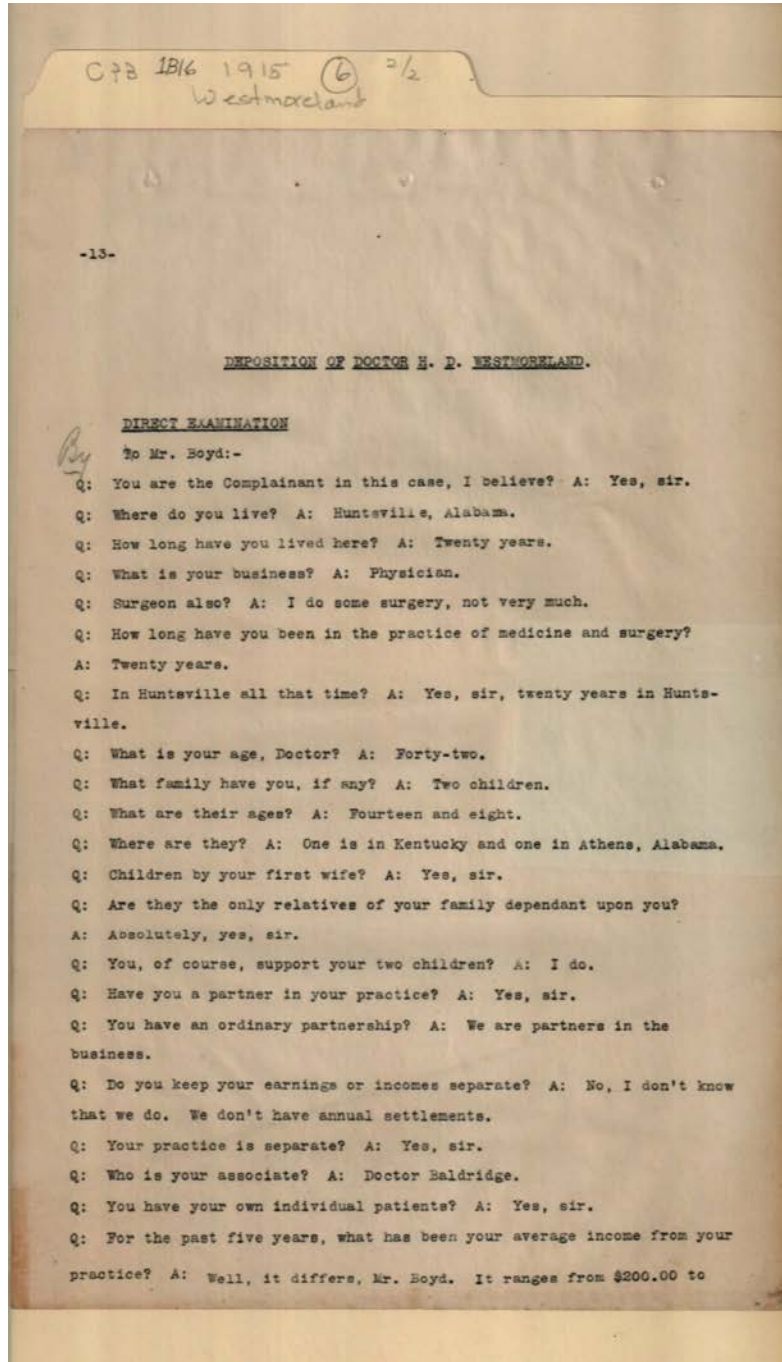

Q: Would you say that your average income has been as much as \$3,000.00 a year? A: I don't think it has. I think \$200.00 a month would be about right. I have done more practice than that in Huntsville during epidemics. My practice has been in excess of that, but during the last five years, I doubt very much if it has been over \$200.00 a month.

Q: What are your earnings from your profession? A: My practice has been somewhat involved seriously during the last few months, and it is not as good as in former years.

Q: What is that attributable to? A: I can't account for it. I have been here attending to it, and I can't account for it. The thing that has transpired in my life has injured my practice.

Q: Would you say that for the last five years that your average income has been as much as \$2,500.00 per annum? A: It probably has.

Q: What income have you outside of your profession? A: I have a net income of about \$2700.00 or \$2800.00. I owe \$18,000.00.

Q: Your net income is outside of your practice \$2700.00? A: Yes, sir.

Q: Then your yearly income would be somewhere in the neighborhood of \$5,000.00 or \$6,000.00 from your profession and outside sources? A: Yes, if my practice holds out.

Q: I am speaking of the past? A: I am looking toward the future. I ~~am~~ have an indebtedness of \$18,000.00 that I am paying eight per cent interest on.

Q: What is the nature of that indebtedness? A: I owe the Henderson National Bank \$6,000.00. Lawrence Goldsmith, \$2,000.00. Shelby Pleasants \$4,000.00, The Volunteer Life Insurance Company, \$5,000.00.
