To the Honorable Ferdinand L. Hammond, Judge of Probate
in and for the County of Madison in the State of Alabama. —
— The Petition of Amos N. Nimmo, and James P. Nimmo, exec-
utors of the Last Will and Testament of James F. Nimmo, late
of Jackson County, deceased, respectfully shew unto your Honor
That the Seventh clause, or Item, of the said Last Will and
Testament contains a bequest in the words and figures follow-
ing, to wit: "I give and bequeath to my beloved wife, Ann M.
Nimmo, for and during the term of her natural life, the fol-
lowing negro slaves, to wit: Ben, a man now aged about 40 or 50
years — Eliza a woman, wife of Ben, now aged about 35 or 40 years
— a girl named Elvira now about 20 years of age and a negro
man named Baldwin (otherwise called Bolding) now about
10 or 15 years old. Said slaves and their increase, upon the death
of my said wife, Ann M. Nimmo, are to return to the residue of
my Estate, and be distributed among them after directed." — The
said Ann M. Nimmo, departed this life on the second day of
May last, whereby the said slaves have become vested in
your Petitioners, as such executors, to be disposed of according
to the provisions of the said Last Will and Testament. —
— At the time of the death of the said James F. Nimmo, deceased,
he left surviving him, the following persons, who were legat-
ees under said Will, and who are, also, his heirs at Law, to wit:
Ann M. Nimmo, his Widow (who has since departed this life)
Amos N. Nimmo (one of your Petitioners) James P. Nimmo
(the other of your Petitioners) — America A. Watkins, wife of
Isham Watkins, — William H. Nimmo, — and Clement C.
Nimmo, the last five being children of the said Decedent. —

All of the said children reside in the said County of Madison, and all of them are of full age, except the said Clement C. Nimmo, who is an Infant, under the age of Twenty one years, and of whom the said Amos N. Nimmo is Guardian. — At the time of the death of the said James F. Nimmo, deceased, he owed sundry debts to a considerable amount, to various persons, many of which said debts are yet unpaid. The personal property (other than slaves) left by the said decedent is not sufficient to pay said debts, and he did not own any land. All the other slaves, owned by him, at the time of his death (excepting the four above named) were specifically bequeathed by him in his said Will to his different Legatees, who have now a vested interest in the same. The sale of these four slaves is, therefore, necessary, to pay off the debts, aforesaid, of the said decedent. — In tender consideration of the premises above set forth, your Petitioners pray that a day certain, to be by your Honor designated, may be set apart for the hearing of the said application — That notice of the same may be given as by law required, and that upon the final hearing thereof, a decree may be made by your Honor, directing and authorizing a sale of the said and all other articles of personal property of the said Estate for slaves, for the purpose aforesaid, by your Petitioners, on such terms as to your Honor, may seem most and proper and to the best advantage and interests of the persons interested in the said Estate. — And your Petitioners, as in duty bound, will ever pray &c. —
