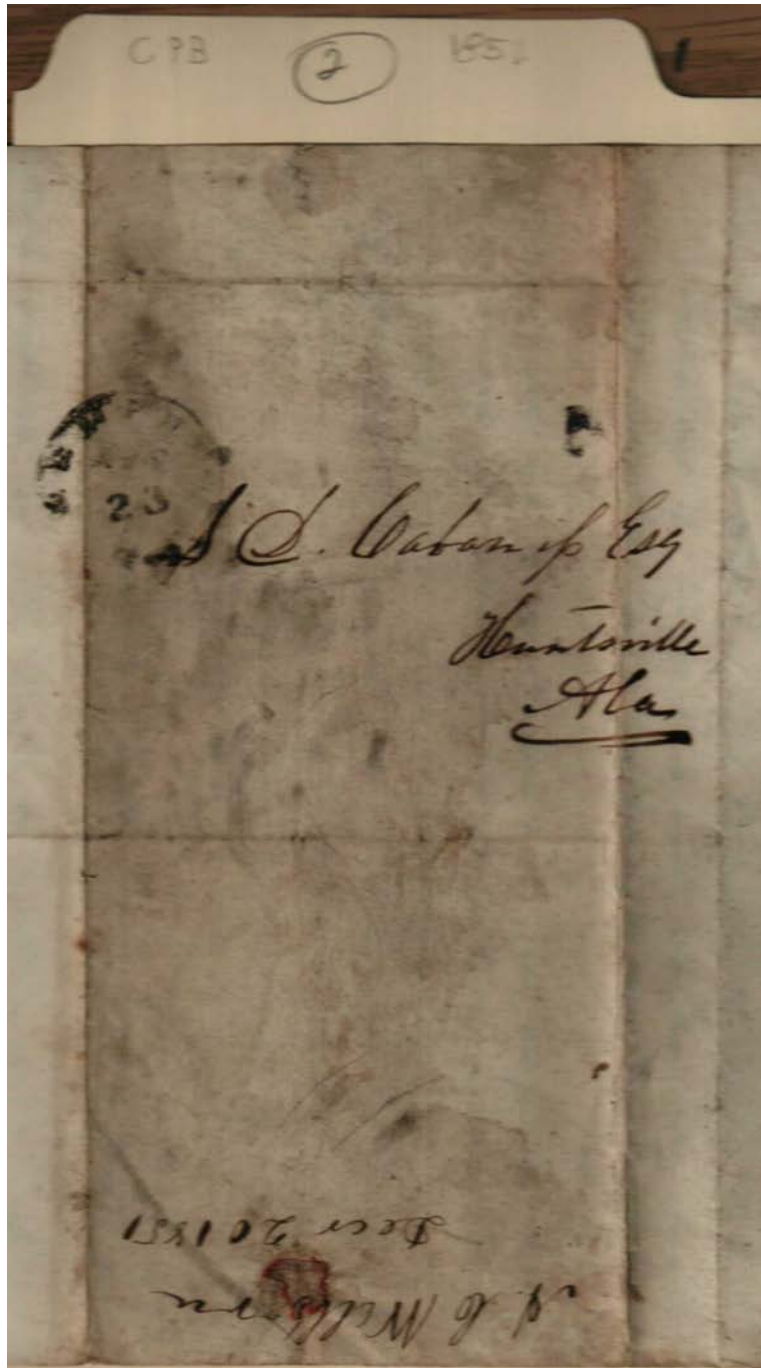

The others live somewhere in Jones and Monroe County the same state, though he did not know their Post-office. The next after Mary Baron is Isaac Jones. I would not ask you at this time, but I am in need, and you must assist me by paying what is justly due. You promised Mr. Turner and Parson Robinson that you would let me have some money. I think you told them at the same time that you had advanced me 1 hundred dollars in specie. you are mistaken. I borrowed 1 hundred dollars in paper from Elizabeth. Besides if you had have paid me six hundred dollars for the expenses and trouble that I was at with those free negroes of yours it would have been nothing but right. I would not have them for the same length of time for one thousand dollars paid in my hand.

I am willing to compromise this matter with you in any way that would be an interest to myself and children, and be satisfactory to yourself. I think it would be best for us to come to some conclusion and determination, and should you think proper to assist me in any way, and you do not wish it to be known by all, I assure you that I never will divulge it to any one. An early answer is requested.

Madam,

On Wednesday morning last, as I was in the act of leaving town, Robert handed me a letter from you without date, in which you say that sometime last year, I promised to do something for the board of my children, or at least to put a woman with you to cook, wash, and attend to them. I had hoped that all this matter had been arranged to our mutual satisfaction. Capt. Turner and Mr. Robinson both know that I protested, as I protest, against the justice of your keeping the children against my will, and then wishing to charge for boarding them. Their clothing, education, and even making clothing for them I pay with pleasure, I don't wish that you incur any expense for them, and surely you do not think it a trouble to take care of your own Grand children, or require pay simply for what they eat. Last summer when I desired to end all difficulty by bringing the children home, you refused to give

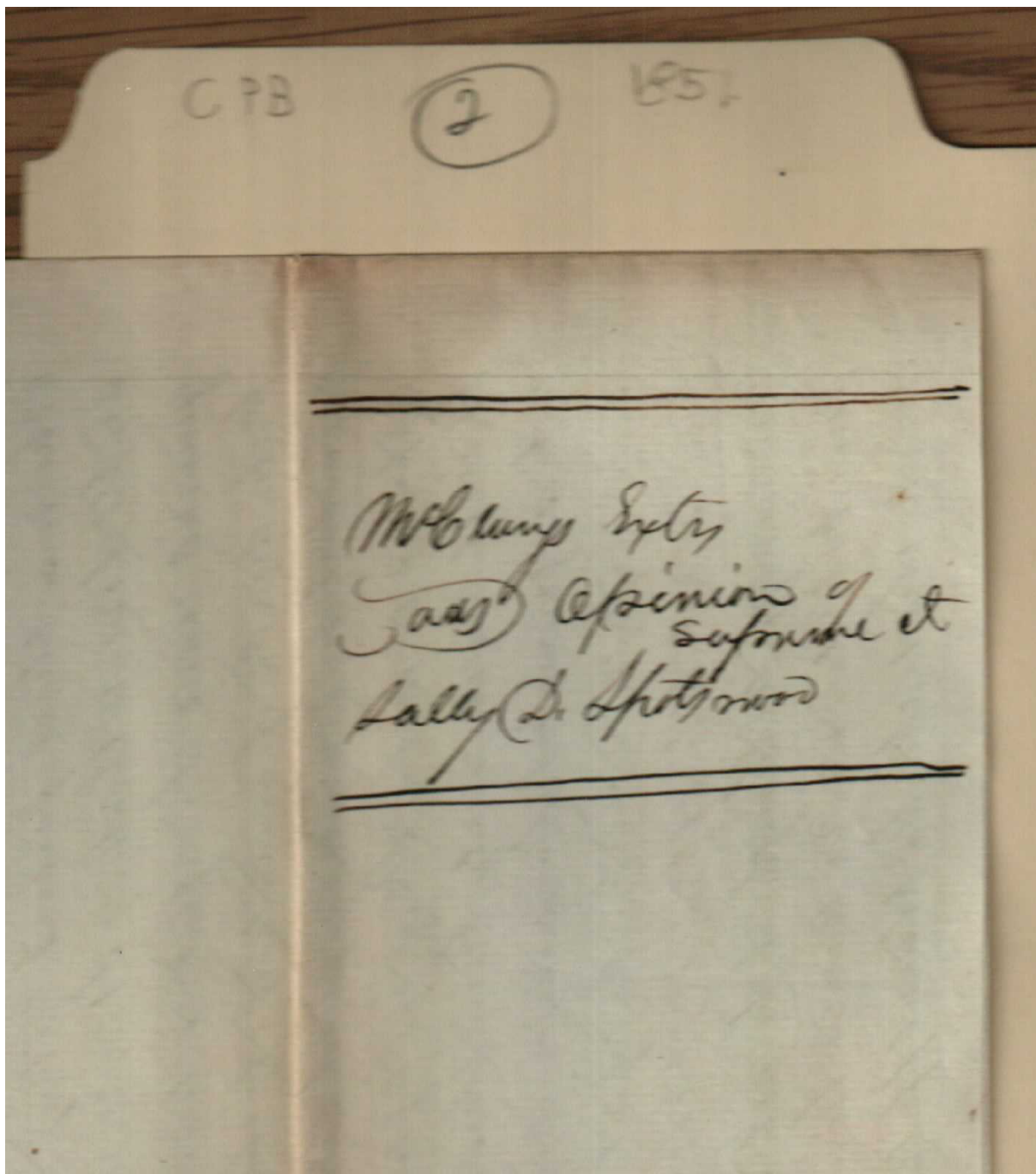

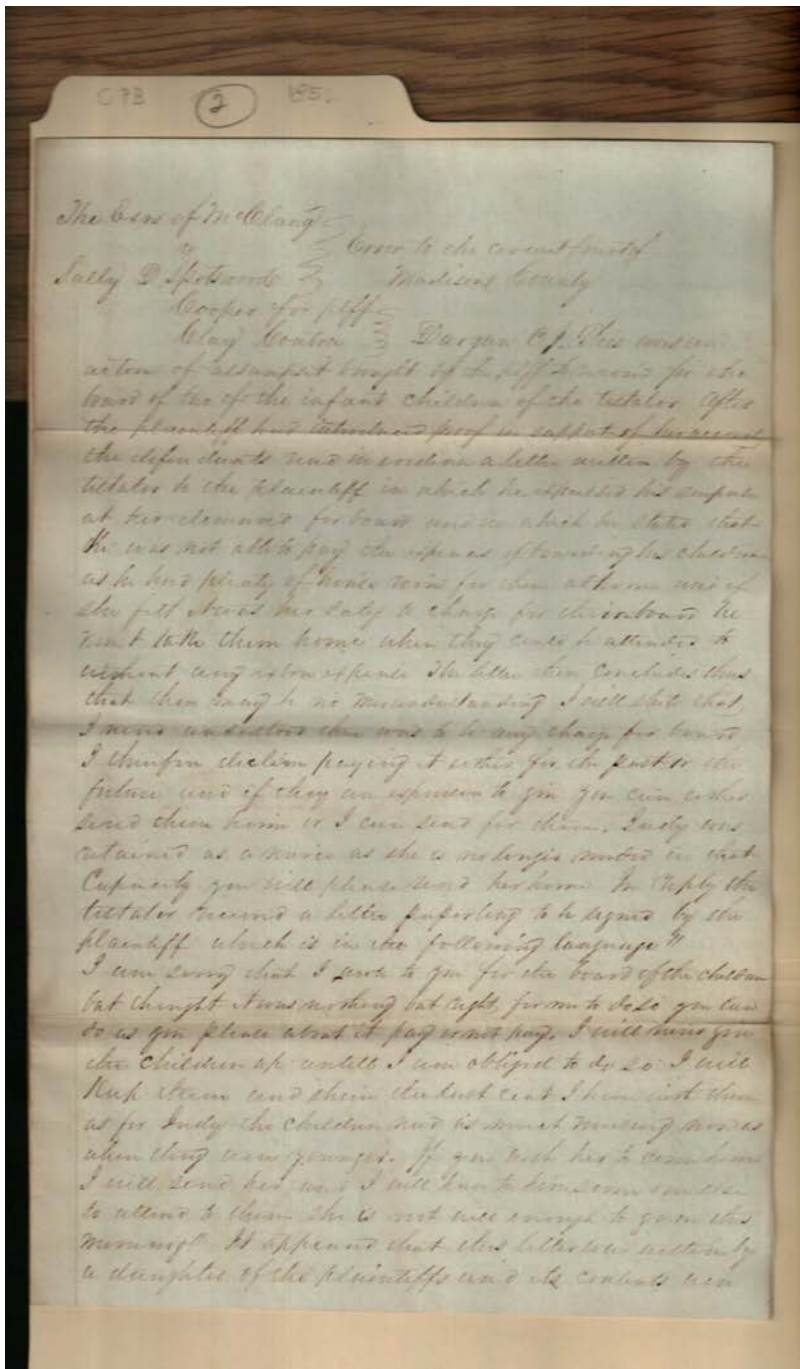

not known to her but the evidence continues to show that when she drafted the letter of the 18th the plaintiff being a paper in writing on the part of the defendant's daughter to answer it but she did not check the character of the answer nor give her any further advice what to write. This letter upon the motion of the plaintiff was excluded from the jury and the objection was overruled without any inquiry as to the effect that this letter would produce upon the minds of the jury in rendering their verdict. It will remain only the question of its admissibility as evidence. It is certainly true that the acts of an agent are not binding on the principal unless it is shown that he was authorized by his principal to do the act or unless the principal has adopted or ratified them after they have been done. But in most cases of mistake the question of agency is a matter of fact which it is the province of a jury to determine upon which the ratification of the Court was of the testimony tends to prove that the person acting as agent had authority from his principal to do the act when it is manifest that the Court can not exclude from the jury the act itself without trampling the basis of his duty was assuming to determine a matter which belongs to the jury to wit the authority of the agent to do the act. The correct rule is that if there is no proof what ever tending to show the agency the act may be excluded from the jury by the Court but if there is any evidence tending to prove the authority of the agent then the act cannot be excluded from them for they are the judges of the sufficiency and weight of the testimony. Applying this rule to the action of the Court in excluding the letter reporting to be written by the plaintiff to the defendant's sister we can confidently hold that the Court erred for there was no question but that there was evidence

Construing to show that the letter was written by the
plaintiff's authority was a question for the jury but
for the Court to determine on the sufficiency of the evidence.
But in appearance that the reason which influenced
the Court in requiring the letter was, that it was not
that the plaintiff had the terms of the letter taken
of the evidence. But the question whether the letter was
written in conformity with the authority given to him
it was all in that case a question of fact for the jury
to decide in most cases when the authority is given by deed
the question whether the agent has exceeded his authority
is a question of fact to be decided by the jury under the
instructions of the Court. In the case of Sturges v. Bridgman
But independent of this view I am strongly of the opinion
that if the plaintiff's daughter was authorized to convey the
letter of bequest, but was not authorized as to the character
of the conveyance to be given in consequence of the
conveyance being the defendant's letter from the testator
to take his children home when the plaintiff is not
bound by the letter as of the kind of property dealt
with. For if a principal clothes his agent with
authority calculated to induce others to believe that the agent
has full power to act, the principal must be bound thereby
otherwise third persons acting in good faith might be injured.
See Wells v. Wells 9 Q. B. 276. And if the authority is
general and the agent is limited by secret instructions as
to the mode of executing it, the party dealing with the agent
cannot be bound by such secret instructions unless he has
notice of them. Stow v. Lymington 17 Q. B. 200. And therefore
it will conclusively from this that if the authority to be given
is not a power to convey or otherwise of a certain kind
then it is not to be affected if the act be within the scope of the
authority, although it be not in the intention that the
principal should or would himself have done it. For therefore

In no point of view can the ruling of the
Court be sustained in rejecting the letter as evidence
and for this error the judgment must be reversed.

in this action and therefore hold that there was no
