Rec<sup>d</sup> of Stephen S. Ewing a note on William Street for one hundred and thirty five dollars & cents, dated 24<sup>th</sup> October 1819 one day after date, also one Ditto A Trimble for one hundred and Twenty Two dollars & 50 cents, dated 25<sup>th</sup> Sept. 1819 and due on the 25<sup>th</sup> Dec. 1819 - also a note under seal for one hundred & fifty three dollars dated 17<sup>th</sup> day of June 1819 due one day after date, received by John Stone to Stephen S. Ewing bearing credit to, the amount of forty seven dollars. Also an agreement between Stephen S. Ewing & David Kyle by which Kyle agrees to give him 7 dollars per acre for acres of cleared land &c which we promise to put on suit for collection
