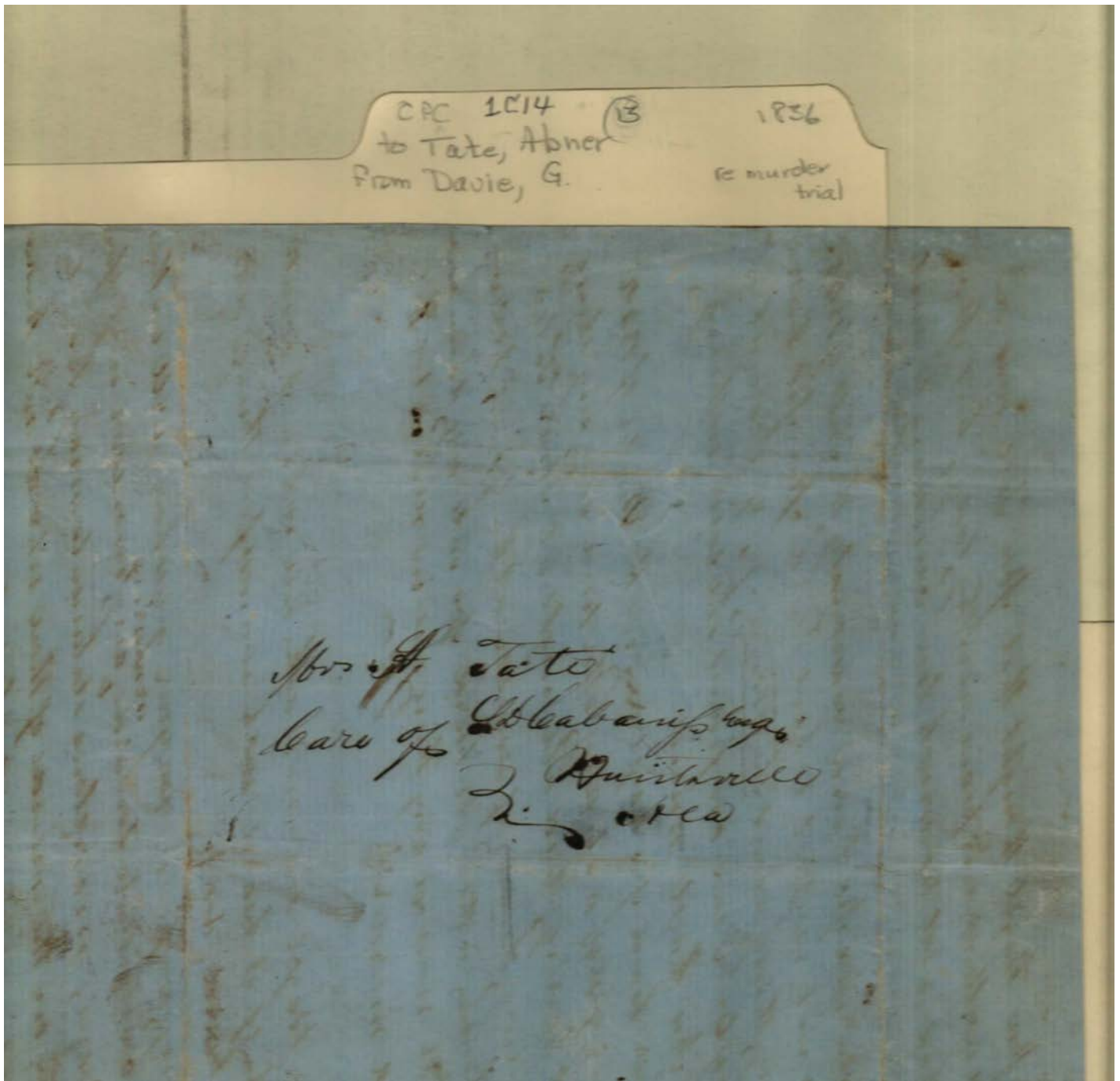

that she never in her life to the best of my recol-
-lection told me about your having murdered
any one.

Ans 1st. (A) I was at Col Taylor's the evening, night
and morning before she started to flee in company
with Col Taylor

2nd. Did not hear the negro man (Affair) say any
thing to her about having any thing which did not
belong to her or about any thing being missing or stolen
from Mrs. J. Daire

3 Did not hear Mrs Hazle say any thing about
stolen goods or any thing of the kind.

4th. Did not hear her (Mrs Hazle) say any thing about
a string or piece of muslin.

5th. She did not appear in my presence or any other
place where I should see a chance to return to Mrs J. Daire to carry a
