1 The Deposit book at Bank of Commerce shows a deposit on 8th June 1874 of \$7500.00. No evidence of any having been checked out p. 786

2 His Deposit book at German National Bank shows the following deposits in May 7, 1874 by - \$2500.00
 May 26, 1874 " - 1500.00
 \$750.00 4500.00

No evidence of any checks yet at C. on Book

3 His Deposit Book at The Union & Planter's Bank shows a balance on May 26, 1874 of \$1200.00 and a deposit Sep. 18, 1874 165.00
 \$129.00 1365.00

No evidence of any checks after May 26, 1874.

II

There are two trust deeds: one to secure the debt of \$6000.00 due C. Kostreche on Bevel's property East of town - these notes begin to mature July 1, 1874 & are for \$200.00 each maturing yearly from after July 1, 1874. The other trust deed is on the Mayorency, two store houses on Bevel St. and to secure a debt due from said Mayorency of \$2000.00. This debt was created May 1873 & Allen amongst his papers has the original note for \$2000.00 due this month. Allen's book on the Union & Planter's shows that the \$2000.00 loaned Mayorency was checked out before the

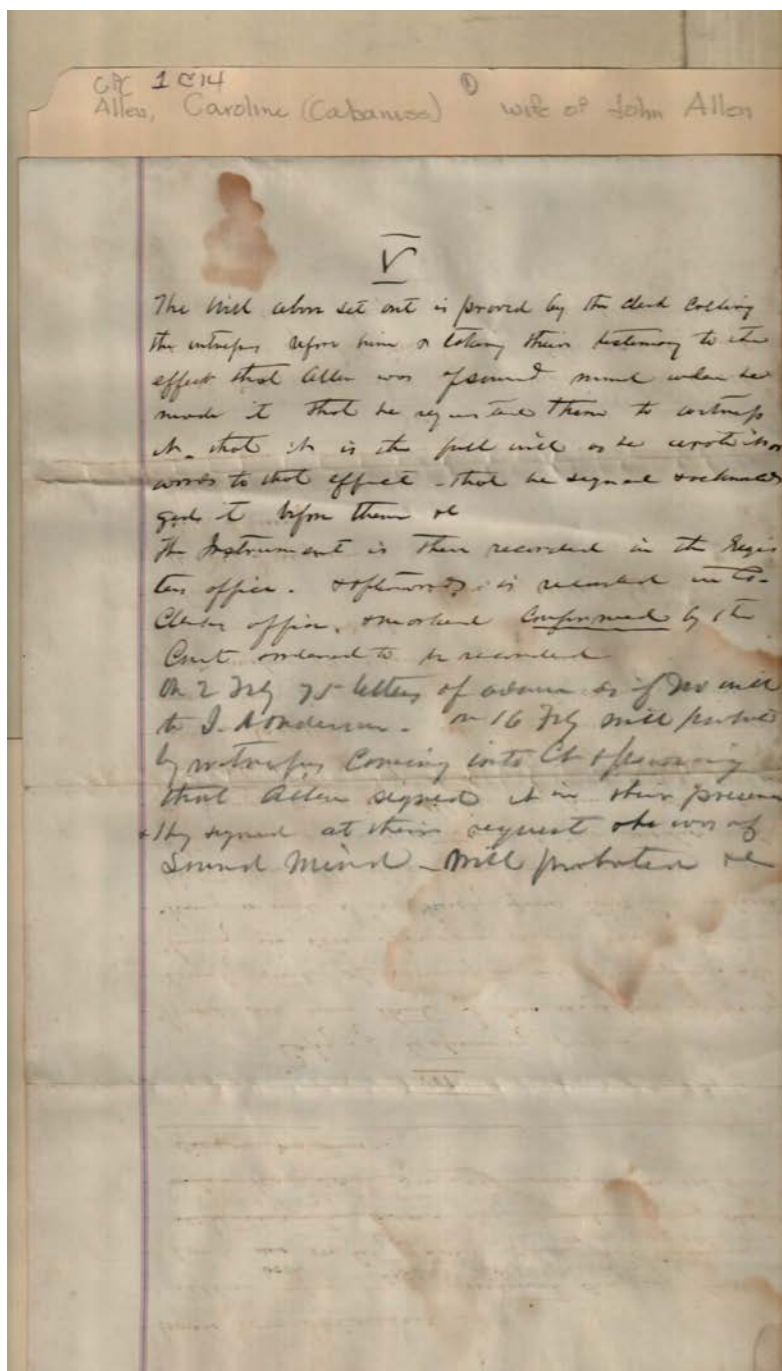

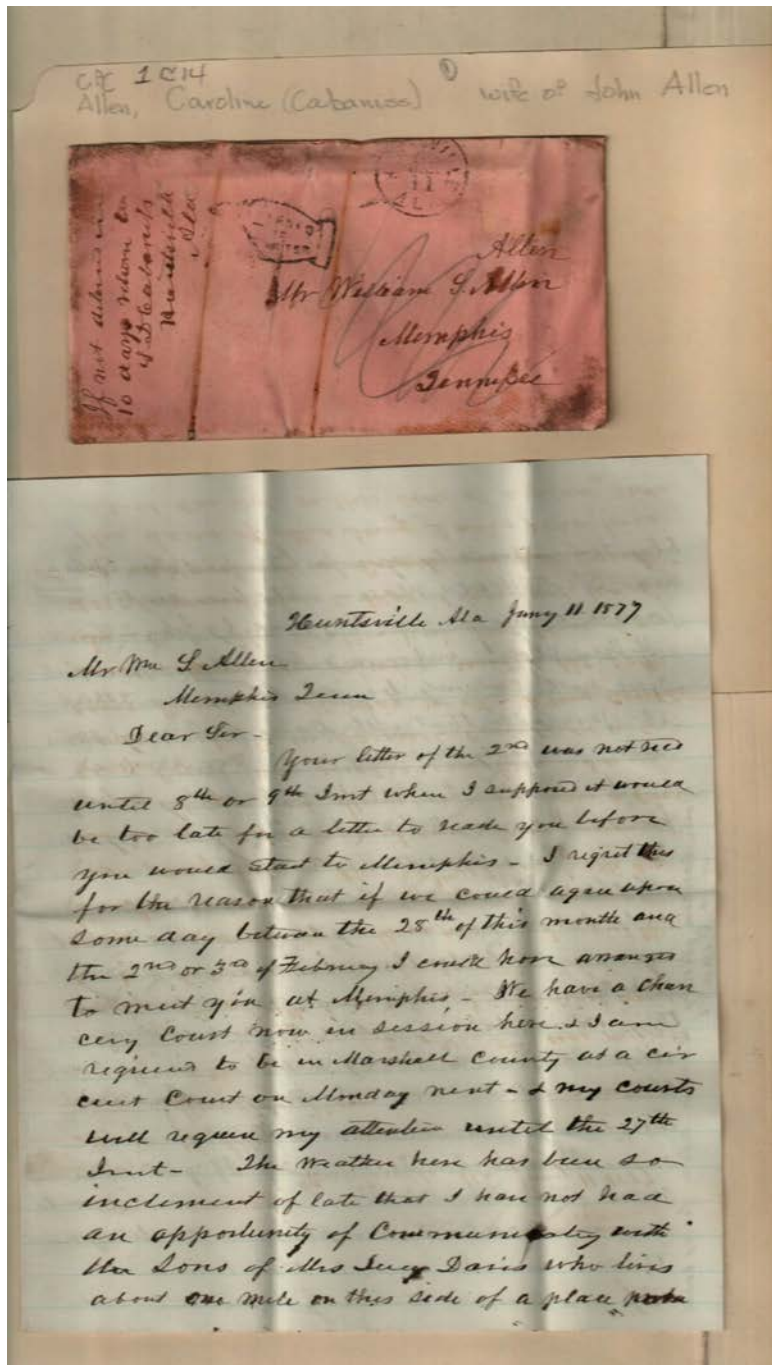

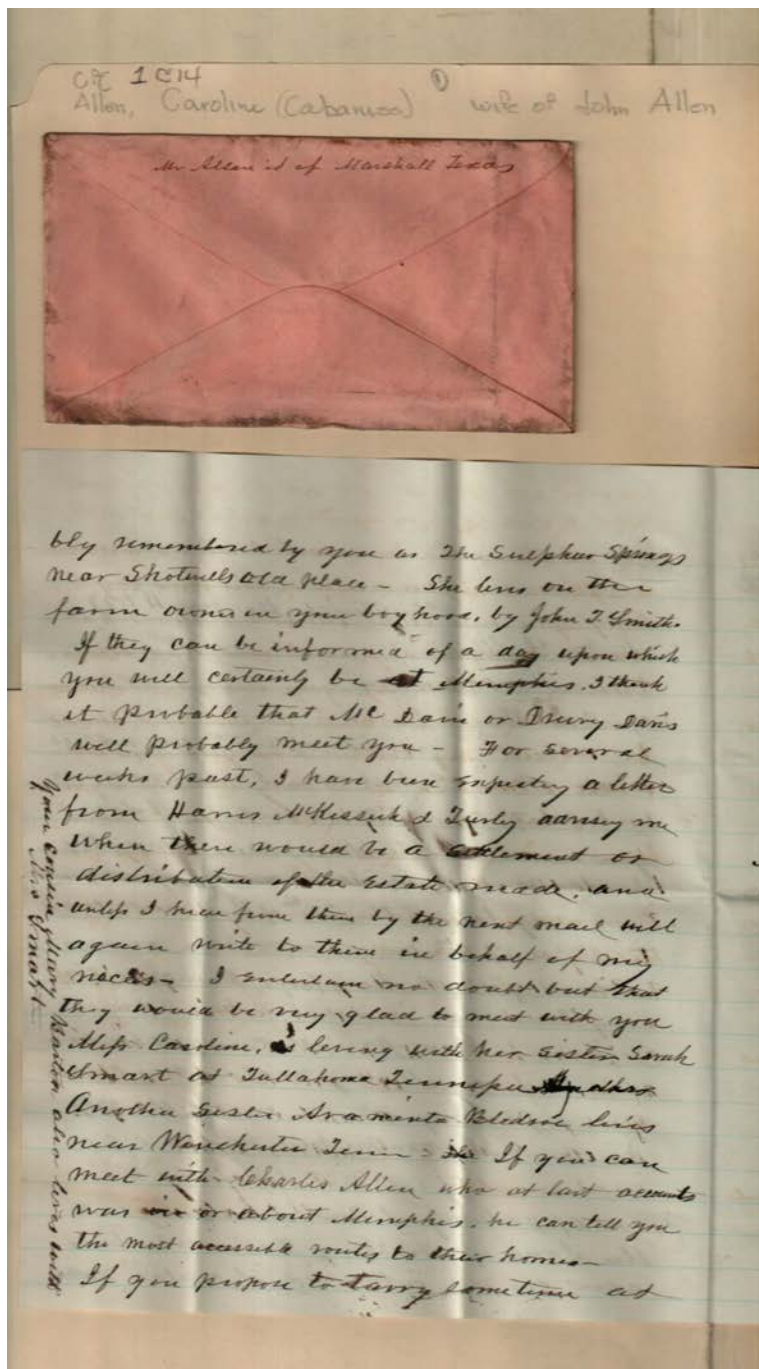

who wrote from Lawrence Bottom P. O. Ark.
He advised me of the death
of his wife on the 17th Dec last. He has two
young children - daughters - Eldest 3 yrs,
the other 8 days at its mother's death -

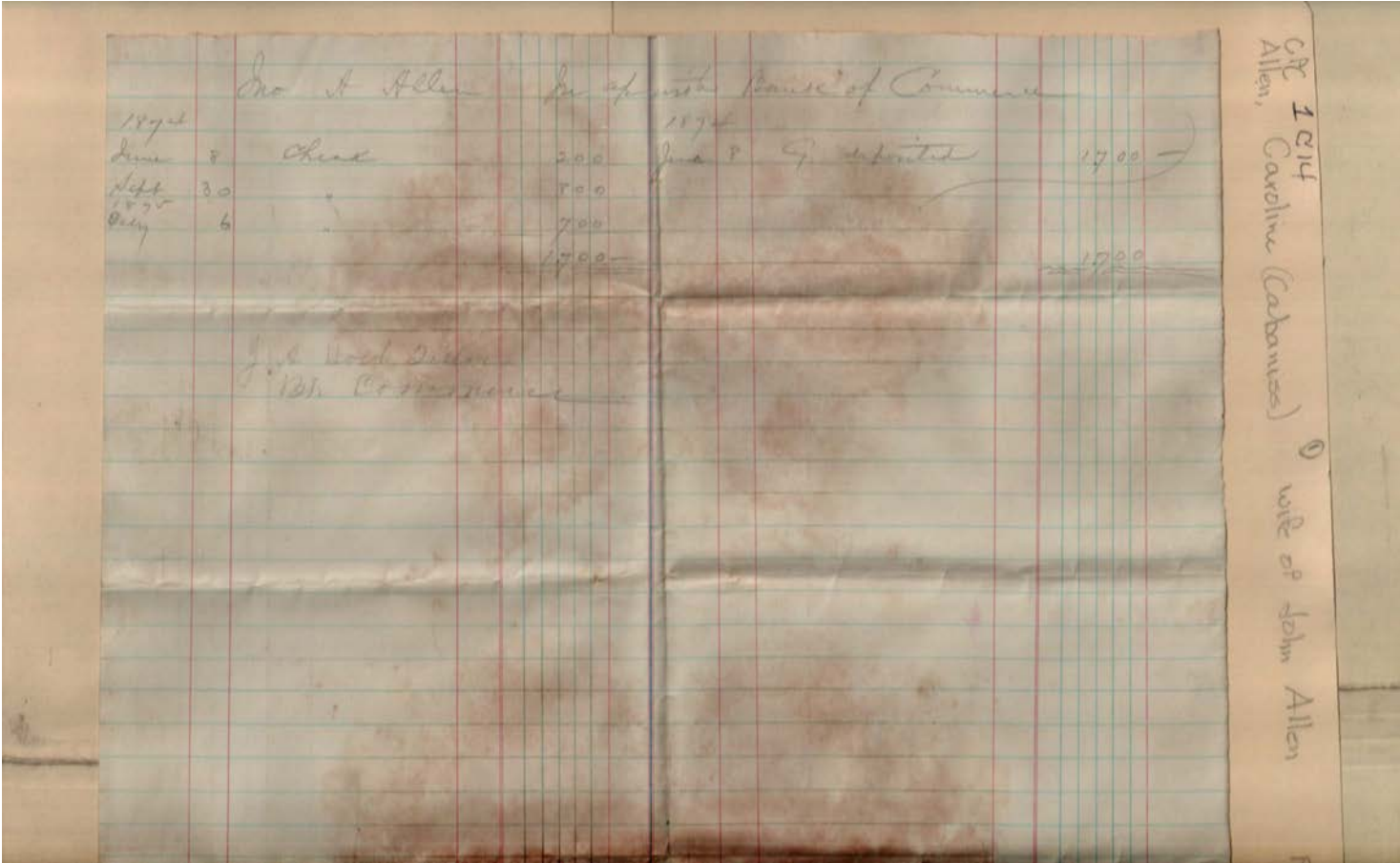
