Dear Mr. Patillo:

In response to your recent letter concerning any records which I might have on John Wesley Shepherd, I would like to report that I do have some materials which would be of interest to you in building your historical records on him.

As you may know from my cousin, Mary Evelyn Carr Quisenberry, John Wesley Shepherd was a brother to my great grandmother (Virginia Shepherd Cabaniss). He was born in Huntsville in a small Federal-style house on Holmes Avenue, educated at Greene Academy and Yale University where he graduated as one of four valedictorians of his class. He was trained in the law by his brother-in-law, Septimus D. Cabaniss, and shortly after being admitted to the bar, he moved to Montgomery where he spent the rest of his life.

I do not have a portrait of John Wesley Shepherd, but I do have portraits of Charles, his brother who was a school teacher, and Elizabeth, his younger sister, both of whom were never married and lived in the little Shepherd house all of their lives. I also have three years of correspondence from John Wesley Shepherd to his family while he was at Yale University. These letters should, I think, go into your collection, and I will send them to you under separate cover.

Since Judge William C. Bibb of Anniston, Alabama, is also a descendent of John Wesley Shepherd, he may be able to help you in the collection of materials. His address is 806 Coleman Drive, Anniston AL 36201...

Would you please send me Mrs. Quisenberry's address, as I have not heard from members of the family in Montgomery in some years.
