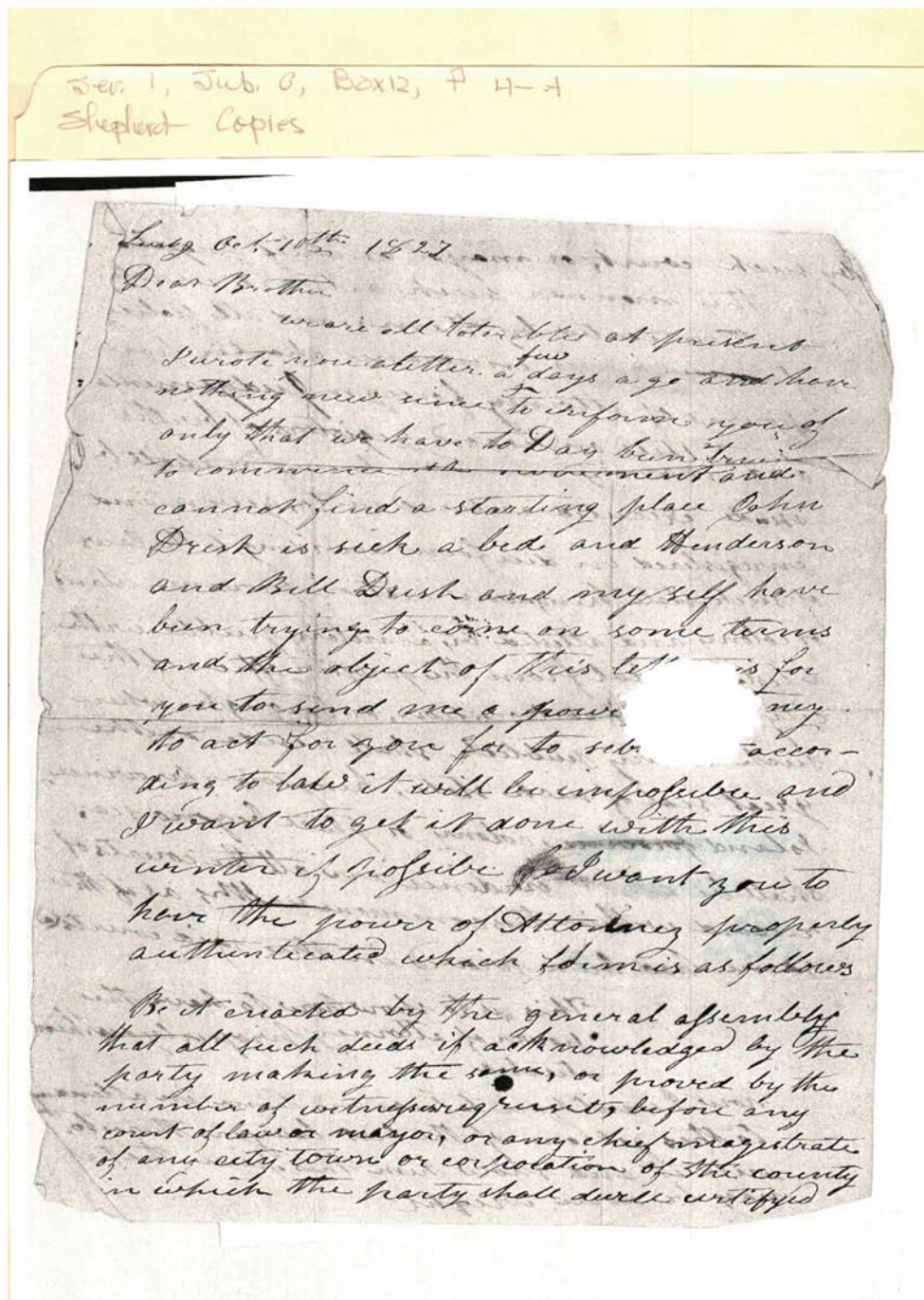

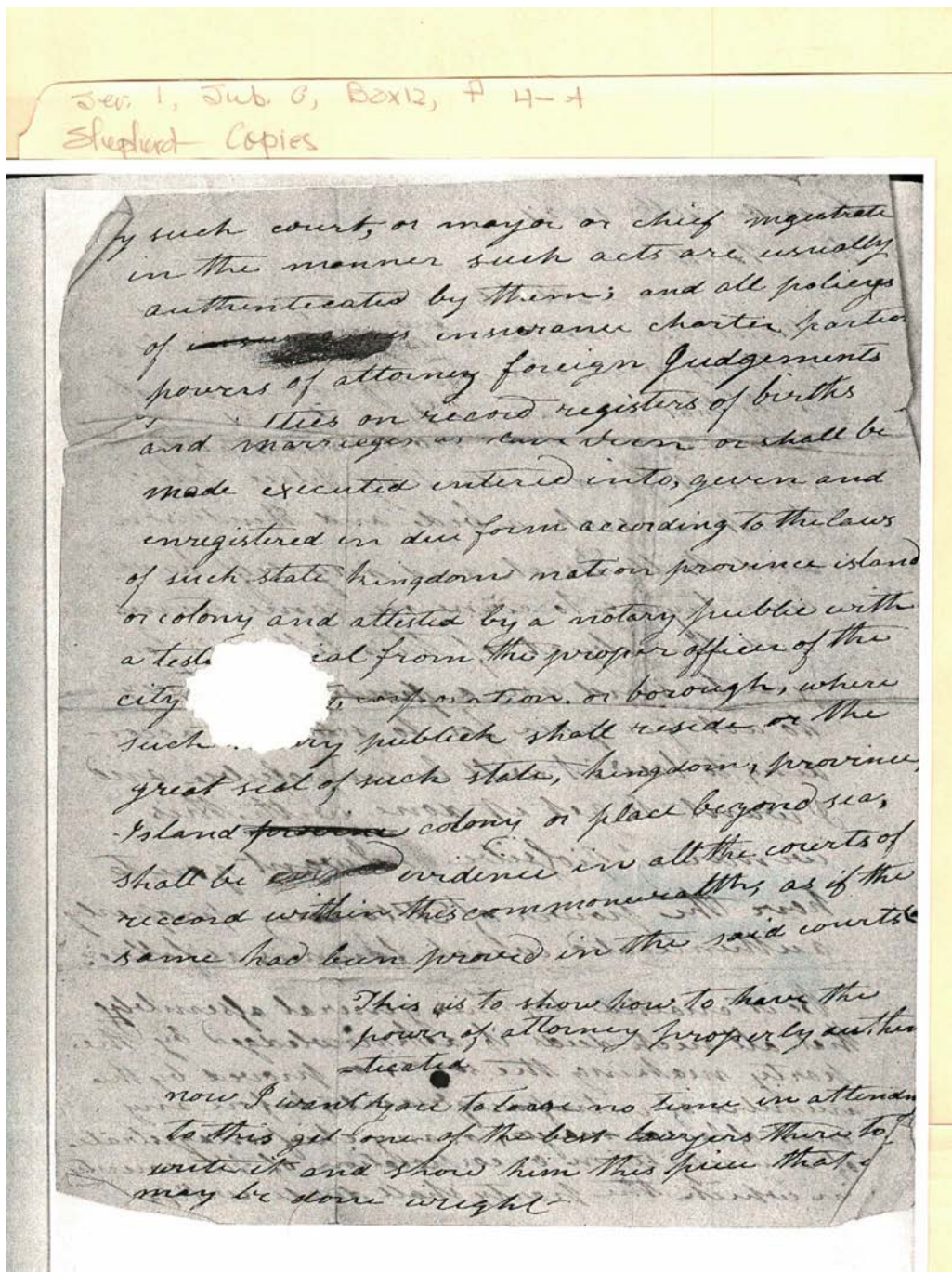

Dear Brother

My reason for delaying writing so long is that I never seen John Harrison untill last week he says he left your receipt with Dr. Powell to give to the same man you first left it with he says it is possible that the Doct. has neglected to give it to him so you can apply to them both.

We are still in tolerable health and have nothing new to write only that I have got the estate settled at last and James as executor falls only six dollars + and some cents indebt but for rents he owes about 2000 dollars Drisk is behind about two hundred dollars John's estate falls indebt to me 250 dollars and you about seventy the rents James estate owes is very doubtful whether we will be able to get I expect I shall be broke I am sued in two cases John R Cooke has sued me for his fee I have had allmost trouble enough to crack my Brains but hope to get rid of it soon
