The note which you hold

the settlement of my family in the place
have taken all the money I have received
for work. I am now, however, conveniently
settled & will be able to pay you when
I make collection. Should your note
for about 6 shillings and a dollar due at
Christmas. I am extremely anxious you
would not suffer the collection to be
urged before that time & you shall
have your money punctually; otherwise
you can get it, but it would be in-
convenient to me to much inconvenience
I am disposed to think you will
myself & family are well. Please write

3 - I am writing to you another letter in about a month at which time I expect to give some account about the settlement. Mr. Powell who is now master comes is settling it and expects to have it ready for next court. It arose you a letter in ~~Sept~~ about taking poor John's clothes but have never yet received an answer from you. I don't want to sell them and I am afraid they will get injured by lying in press write to immediately whether you will take them or no. I have not yet sold the land and secured and warranted for about 200\$ which was the balance due on the house. It sold under a trust for about 200\$ and the interest and cost amounts runs it up to what I am secured for. I have laid myself liable for the money through ignorance and the way it happened was as follows after I made sale I made use of the funds to paying off accounts (which exhausted the funds) and thought that the house and lot was all that was bound for the debt but thought as soon as I could sell the land to pay the balance, but I can not sell the land and therefore I fear I shall be made to suffer. Give my love to Kitty and Anne.

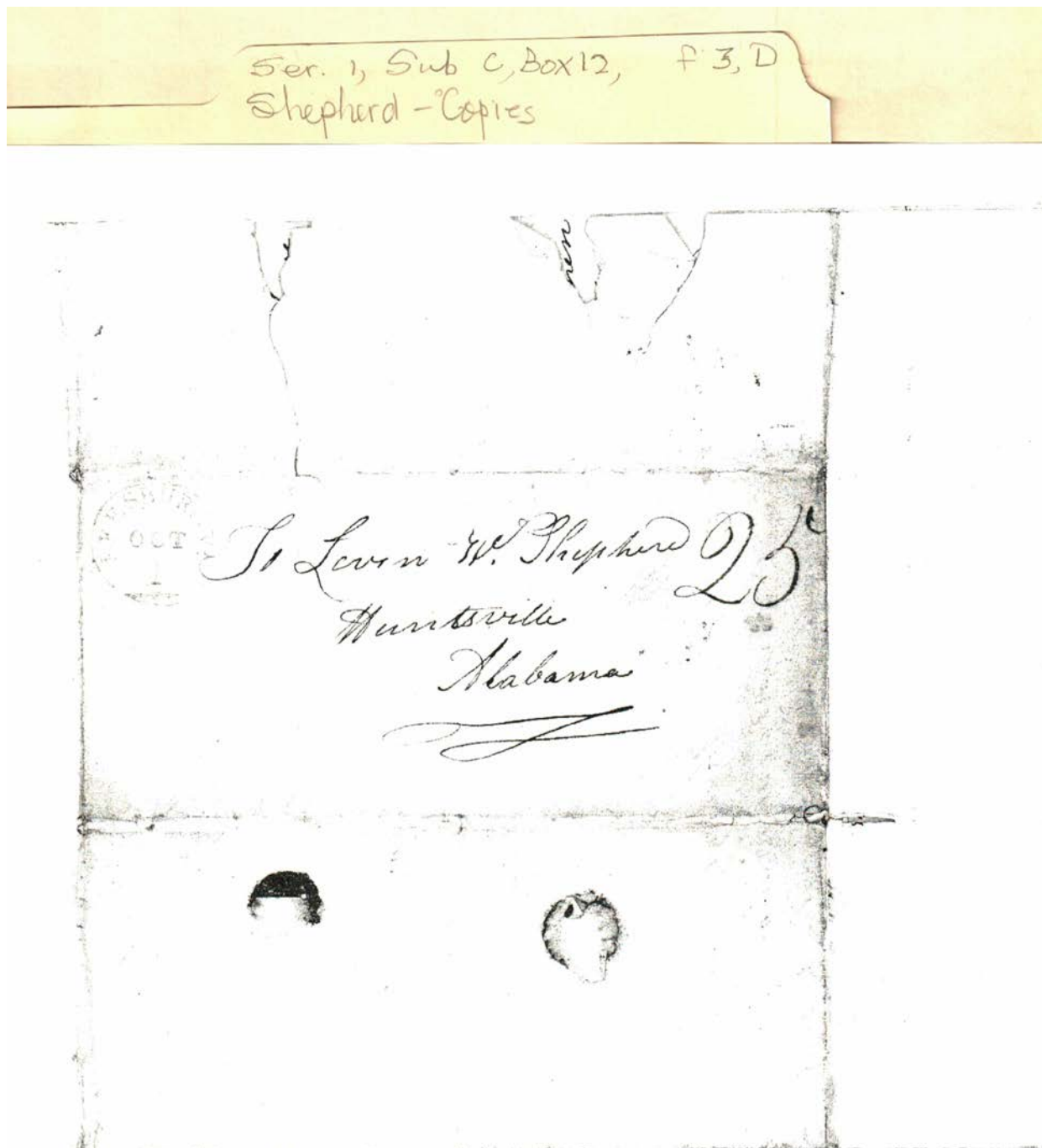
