I received your letter to day - have been waiting for the money, I promised Gov. Chapman - it has not yet reached me - I will come down Monday - I proposed giving Gov. C. a mortgage in preference to giving him security - In as much as I am engaged in business, I think after reflection, that it would be better for me to give personal security - this I can well do - I will make the money perfectly safe - I wish the Gov. to give me as long time as he can, say at least 12 months. My brother John H. Larkin & C. A. Staples will go on the note - I went to Scottsboro to day will bring down the agreement. Very truly
