I received your letter Monday and read its contents. There was some satisfactory information contained in this communication. I can now see the condition the estate is in at present & also the need of a lawyer to look after our interests in the matter. It seems that the testamentary paper has been admitted to probate and an administrator appointed, therefore the case of the negro interests is to rest upon that short document. We are in favor of contesting the will at least so far the Rhoss are concerned, and we would like you to see the lawyers W. S. Allen have employed or write to them and make such a contract with them as you think best. I am willing to pay ten per cent of whatever they may collect for us. Do you not think we had better do that & will you act as our adviser in making this arrangement with the law firm. I will wait to hear from you before I write to any one else. Ought I to write to Araminta anything about the matter, how it stands. Please write soon, or at least when you get a hearing from those lawyers. I would feel satisfied if
