My dear B.

E. has to come to town to the funeral, so I send this by her. The note I gave you yesterday pays O's interest to E. up to the close of this year, and E. will sign the receipt enclosed. The other note I hold is for money due me by Bertha. It was given to her by O. in settlement of the personal estate, &c. Nov/85. O. could not pay it when due last year, and so it was laid over to the present. It will be due Nov. 25. It is important that it should be paid at that time, as it is the money B. borrowed from me on this note which has secured the insolvent note of W. R.

It is dated Nov. 25, 1885 for \$218 with interest from date. Nothing has been paid on it. \$20.67 with interest from Jan 1/87 is coming to me. I would prefer that O. should pay me only that amount.
