the have breakfast very early in order
that we can get to work. Mr Moon
has helped Fearn four days, & I guess
will finish up without further trou-
ble. In regard to the old man you
was not exactly right, and not very
far wrong, he is not altogether a deacon
in the church, but is a member in
full fellowship. He is one of the
necessary evils that is in nearly
every community, we could not
well do without him, & we can
hardly do with him. He is ready
to help when you don't call on him
and is always very busy when you do
call. He has a fine hog that he wants
to send you when Fearn takes those
down. Mr Russell spoke today for four
fine hogs & have a prospect of buying
them, pork is $3\frac{1}{2}$ to $3\frac{3}{4}$ cts gross every
body is trying to hold back for higher
prices. One that we have, will
not be able to take the long trip
she will have pigs in a few days.

I didn't know this when I wrote
you a few weeks ago. She is the
largest of the three. We have a young
steer that we are trying to trade for
pork, if we had a match for him I
would rather not sell, but we
cannot make him without a
good deal of trouble, and as cotton
is so indifferent the seed will
not be fit for cattle & that will
make feed short, so we had
better get rid of him.

Tonorrow is the day appointed
to lay the cornerstone of our house
the logs are ready to raise, let us
hear from you soon. Fearn will
have to go to Paint Rock station
this week for flooring.
We have the promise of help this
week to pick our cotton out if the
weather keeps fair we can get it
out in a week or ten days with
one hand to help. I hope the rail
road will be built very soon.

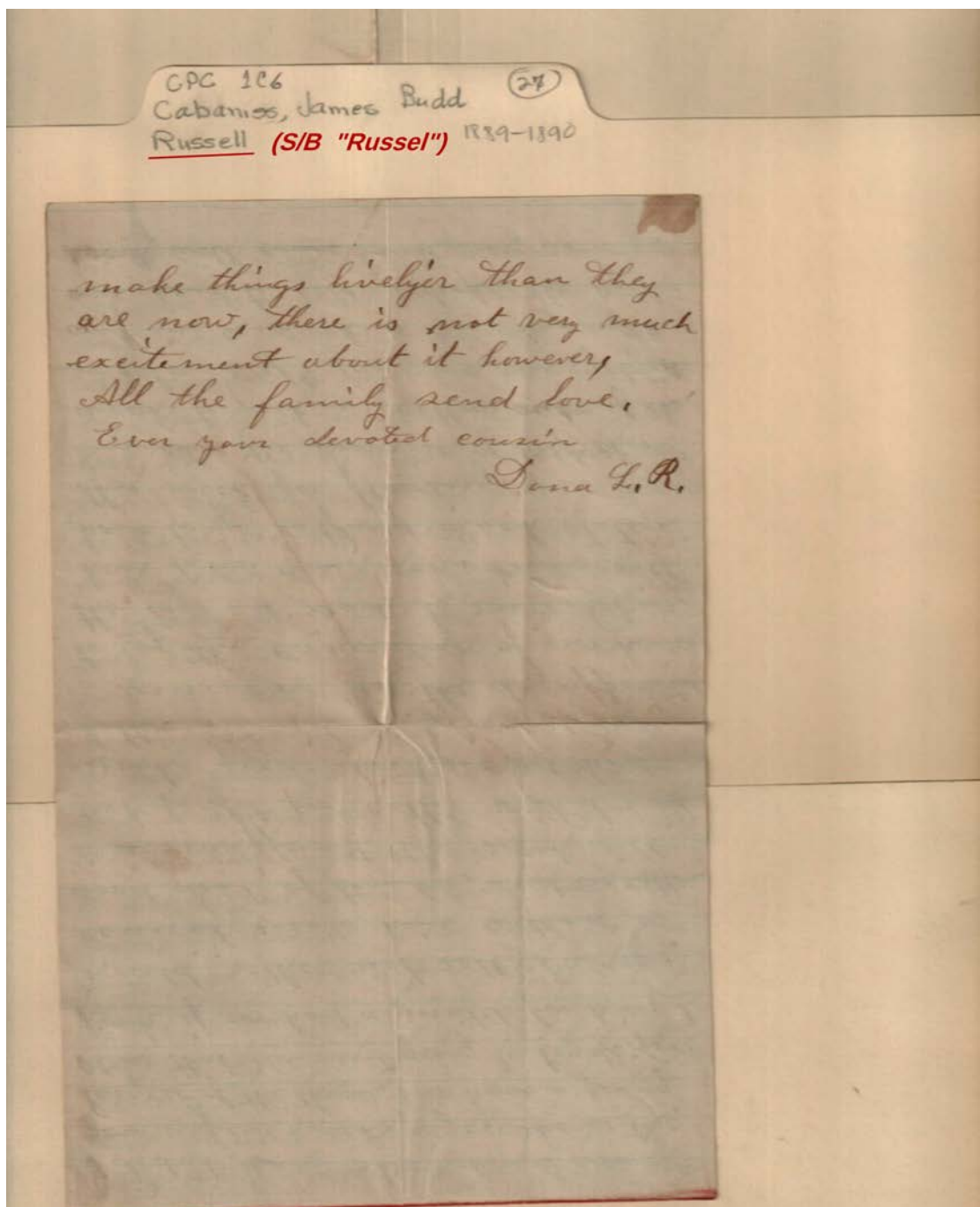

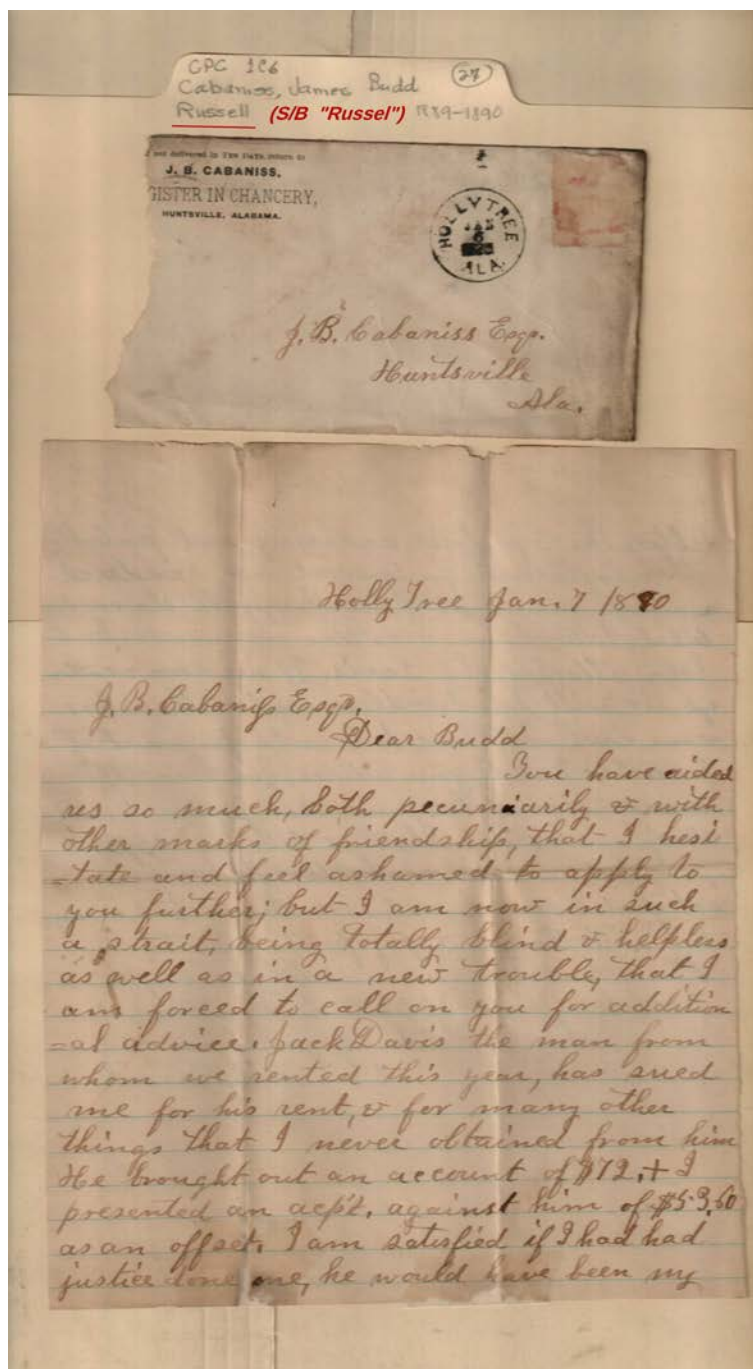

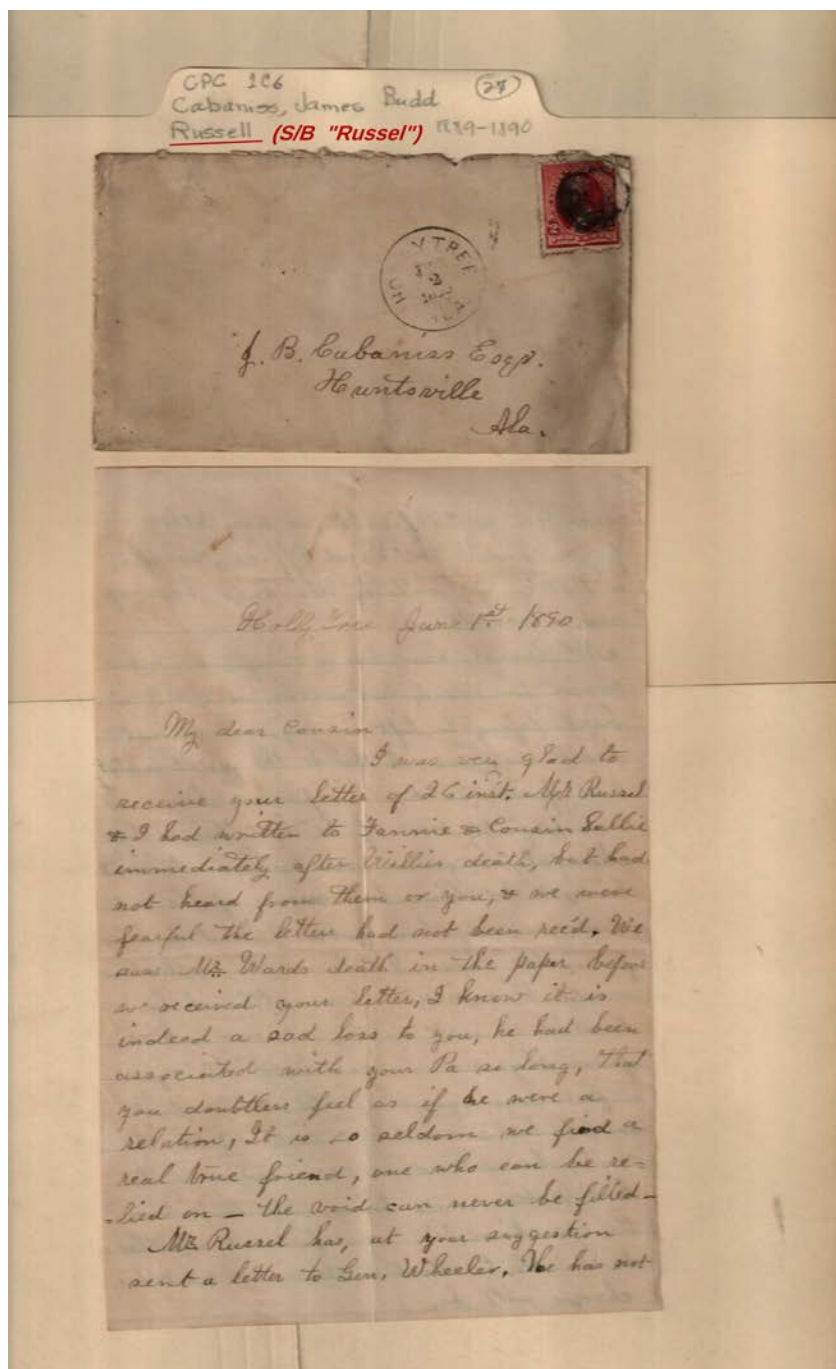

Mr. Russel has been confined to his
room for nearly two weeks, he hurt his
back trying to lift a log, his general
health is good, I think the good water
and pure air has improved him
wonderfully, now if he had two or three

him, & let him hear more of the out-
side world, than what I read to him
from the papers. I believe his affliction
would be easier to bear, although he
bears it as well as any one could. One
of our physicians examined his eye
a few days ago, and told him if it
could be worked on right away, it
could be restored, he recommended Dr.
D. Robinson as being able to perform
the operation, Will you find out wheather
he is able to attend to the case & what his
charges will be.
