Your opinion of my brother's case is very much what I expected, except thte while I knew that he was of a peculiarly nervous temperament, I was not aware that he suffered from any particular nervous disease. For some tim time past, he has spoken frequently of his dread of being afflicted with epilepsy. Only a few nights before he left, he awakened very much frightened and called to me that he had had an epilectic fit. but as he showed none of the symtoms, I thought it a dream. Before going to bed, he had talked a good deal about his brother Willie, now deceased, who suffered many years from violent attacks of epilepsy (traumatic). The ties of affection and sympathy being unusuall strong between the two boys, and the fact that he was then occupying Willie's room, fully accounted for the sensation, I thought. After a long spell of sickness in 1899, he was put under the care of Dr.Gilbery Greenway, at Hot Springs, Ark. with very beneficial results. His health was much better until Jan. 1901, when after an attack of grippe, he resumed the use of stimulants, and when he could not sleep, used sedative medicines . Within the last five years, he has, through ill health, security debts and other misfoutumes, lost all his property, and has developed a morbid dread of poverty for those he loves best. He worries


