WITNESSETH: THAT WHEREAG the parties hereto have considered the need of a civics textbook, properly illustrated, suitable for use in the schools of Alabams at the minth grade level, and the Publisher being of the opinion that a work of this kind, properly prepared, would have sufficient sale to warrant its publication, AND WHEREAS the Authors are desirous of undertaking preparation of such a

IT IS THEREFORE AGREED;

 That the Authors will undertake the entire editorial preparation of the proposed publication, which it is contemplated will consist of one (1) volume of approximately 500 pages.

2. That the Authors hereby warrant that the manuscript pursuant to this contract shall not infringe any copyright of any other publisher or person and agrees to indemnify and save the Publisher harmless from any all damages, costs, and expense by reason of any claim of copyright infringement.

3. The Authors agree to conform so far as practicable to instructions from the Publisher in matters of form and etyle of menuscript, and to furnish the same to the Publisher in typewritten form, the same being typed double-spaced and on one side of the paper only.

 The Authors further agree that the completed manuscript for the proposed publication will be completed and in the hands of the Publisher by the 1st day of August, 1050.

5. The parties hereto agree that the copyright to the proposed publication will be taken out in the name of the Publisher, and shall remain its property, but with the understanding that if the Publisher determines to publish a new edition of the work, other the Authors may have the option to prepare such edition of the work, on the same royalty basis mercin after provided, or on such other royalty basis as may be mutually agreed upon at the time; subject to the further provision that the Authors shall have at least one year's written notice from the Publisher that the Publisher wishes and intends to bring out a new or revised edition of the work, and in the event the Authors are unable or refuse to revise the book, the Authors hereby agree to furnish a collaborator to revise the book, and in the event the Authors fail to furnish such a collaborator to revise the book.

6. The Publisher on its part agrees to accept such manuscript submitted and to publish the same, when in its judgment such manuscript is satisfactory in form and substance and suitable for the purposes intended, provided such manuscript is submitted within the time specified above, or within any reasonable extension thereof which may be mutually agreed upon. The manuscript when accepted shall immediately become the property of the Publisher.

7. The Publisher further agrees that when the published book is prepared it shall be in sufficient quantity to submit same to the State Textbook Committee of the State of Alabama, and to the Alabama State Board of Education, for adoption as standard textbook in the Alabama schools. 

8. The Publisher further agrees to bear all expense incidental to reproduction and the publishing of the Authors' manuscript, photographs, and illustrations, and all expenses of bonds to the State Board of Education and all expenses of printing, warehousing, and distribution of said work. ROBERTS.) all royalties being based on the gross wholesale price of theorks / the Publisher specifically reserving to itself the right to sell the published work at discount, in quantities to other trade houses for resale, and any price placed upon the published work is to be determined by the Publisher in the light of projected costs of the publication and anticipated sales thereof. Records of sales shall be kept by the Publisher and royalty payments made to the Authors, their heirs, administrators, or assigns, on or before the first of November of each year. The Authors may examine the Publisher's records to determine the number of copies of the books that have been sold whenever the Authors desire such information. In the event the Authors survive the Publisher, and the Publisher's heirs or assigns do not wish to ontinue publication of the book, then the Authors may purchase the copyright and whatever plates the Publisher owns for fifty (50) per cent of the original cost of said plates; provided that the Authors will have no such rights unless the Publisher's heirs wish to abandon publication of the book

11. The Publisher further agrees to furnish the Authors, free of charge, twenty (20) copies of the published work when the same is completed, in consideration of which, the Authors further agree to prepare such teachers manual, outlines, or other condensed versions or information about the work as may be required by the Publisher for advertising or promotional activity in connection with marketing and sale of the book, the same to be furnished to the Publisher within a reasonable time after the same shall have been requested of the Authors in writing.

12. The Publisher further agrees to advance the Authors 300 per page for typing against royalties.

13. The Publisher further agrees to pay the costs of obtaining all photographs, drawings, and other illustrative material deemed necessary by the Authors; the Publisher agrees to furnish photographs and illustrations for the text, but any graphs, charts, or test-like material shall be prepared by the Authors.

14. Royalties from the sale of radio, television, serial, or any rights other than book rights in the published work shall be divided equally between the Authors and the Publisher, under the same conditions as hereinbefore provided.
