- 1 -Remove Beautificaion sign and return to the City with our

- 2 -Take down the sign at the number one evap and refurbish it
for hanging in the new building - 20 Thousand sq. ft. HOUSE FOR COCA-COLA
- 3 -Dig up all sidewalk brick, palletize it for storage.
- 4 -Return to Dr. Roberts her "Carriage Steps" loaned to us
so many years ago. Install them wherever she would
like and in whatever manner she choosess.
- 5 -Remove the Monte Sano Hotel light post and prepare it for
installation at 2117.
- 6 -Contact landscape shrubbery removal and move same to proper

wood then stack appropriately at 2700.
