Dear Mr. Stokes:--

Answering yours of some three or four days ago, relative to the amalgamation of the several policies on Church of the Nativity, beg to advise that I wish to hold up this matter until a Vestry meeting first Sunday in next month, August, at which session will discuss with them just how they want the policy to read. I feel that the 3/4 Clause should not include any part of a risk on the Chapel now that we have a separate policy insuring the Chapel.

Policy No. 33-1482 insures altar, movable furniture, etc., for \$500, and the organ for \$2,000 and the balance, \$7,500 on Church building, Total \$10,000. When these policies are amalgamated hope to increase the insurance on Church building to \$27,500, which will increase the insurance an additional \$1,000; however, will give you definite information regarding this just as soon after the Vestry meeting as possible.

Referring to your letter of May 9, 1936, you list the following policies on the Church as being in force: No. 33-1482, No. 33-1481, and No. 1480, a total quarterly premium of \$13.85. I mailed you check on June 8th, \$40.95 to cover a period of nine months, advance. You also list in your letter of May 9th policies Nos. A-2281, A-1325, A-8309, and No. 33-1730, a total quarterly premium of \$10.60, I mailed you check on May 26th, for \$21.20 to cover a period of six months advance. These payments I am so in hopes will take care of insurance on Church to first of year or even beyond. I wish that you would please advise me just how these two payments will make us stand that I may furnish this information to the Vestry at its meeting. Would like also this information, if we desire to pay this premium in twenty installments, on a five year contract, would be granted this privilege if it became necessary for us to ask this consideration? Would appreciate any other information beneficial in this connection that will be beneficial to the Vestry.

Mrs. Ray is in receipt of notices for premiums on policies Nos. A-6454 and A-438, she does not seem to know what these cover, will you please advise in letter in answer to this and I will convey to her.

Under separate cover mail you a letter booklet historical of our Church, picture of Church will give you some idea of connection of Chapel and Church. Trust you can find time to read, believe you will enjoy it.
