22 June, you see how hobblingly + get on  
my dearest brother, but as the fate of the Great Nation appears to be  
at length fixed, from accounts received contemporaneously with your  
much esteemed favor of the 29th Ultio... I can now devote my mind  
entirely to you, or rather to myself. You may readily conclude as  
the French have discarded Bounaparte, I shall no longer follow his  
example- to that how great a General he may have been, one of your  
instances is quite in opposite, and if I can but be with you in time  
to make the Last Impulsion, + may hope a better result than too great  
a reliance on the first. Having by the frankness of my communication  
by Uncle Nick, as well as by its forerunner, opened my Case, and  
shown you how unguarded I stood, you have had a very pretty text to  
preach from; and accordingly I give you credit for the justice you  
have done the subject; and as you are so able a negotiator, I may  
as well make a merit of necessity and continue to employ you, not-  
withstanding the declaration of Neutrality; to throw in temporary  
Seconds for my relief- Untilay notes given yesterday are run for  
64 days- when I hope to take them up; (by which time your Carriage  
will be ready ( having just bespoken it) and you may look for me  
to fight my own battles early in September. Then you see I shall  
not have to take the field during the Sultry months of August and  
consequently may expect pleasant weather! And I am perfectly sen-  
sible that this arrangement will make my stay with you very short  
and that you will say I might ad interim have accompanied the bearer,  
my friend, Lt. Slaughter, returned and gone again by so distant a  
day; but then you must reflect the risque my brain would run, in case  
of disappointment, altho + will not for a moment admit such an idea
