 John Brahan & Others between LeRoy Pope and Judith Pope his wife
 of the County of Madison Mississippi Territory of the one part and
 John Brahan, Peter Perkins, David Moore and Louis Winston Commiss-
 ioners appointed by Law for the Town of Huntsville in the County and
 Territory aforesaid of the other part, Witnesseth that the said LeRoy
 Pope and Judith his Wife for and in Consideration of the sum of
 seven hundred and five dollars to them in hand paid the Receipt
 whereof is hereby acknowledged have bargained, sold, aliened, enfeoffed
 and conveyed and by these presence do bargain, sell, alien enfeoff and con-
 vey unto the said John Brahan Peter Perkins David Moore and Louis
 Winston Commissioners as aforesaid and their successors in office or assigns
 a Certain Tract or parcel of Land situate lying and being in the
 County and Territory aforesaid whereon a part of the Town of Hunts-
 -ville is Established. Containing Thirty Acres and being a part of
 of the South West Quarter of Section No 36 in Township No. three of
 Range No. one West of the Basic Meridian. Beginning at the east
 corner of the Town of Huntsville near and opposite to Lot No. Seventy
 Two running with the North west line of Lincoln Street so to point
 opposite the Junction of No. thirty six and forty Acres with the
 dividing Line of those Lots continuing the same course through the
 Centre of the Public Square thence with said boundary to
 North West boundary of Fountain Row thence with that boundary
 line to the South west boundary line of Henry Street thence with
 that line to the South corner of Williams Street, thence with the

 and that they will not injure or cause to be injured the quality
 of the water in the Spring by erecting any dam or Machinery
 so as to produce Stagnation and Injure or endanger the health of

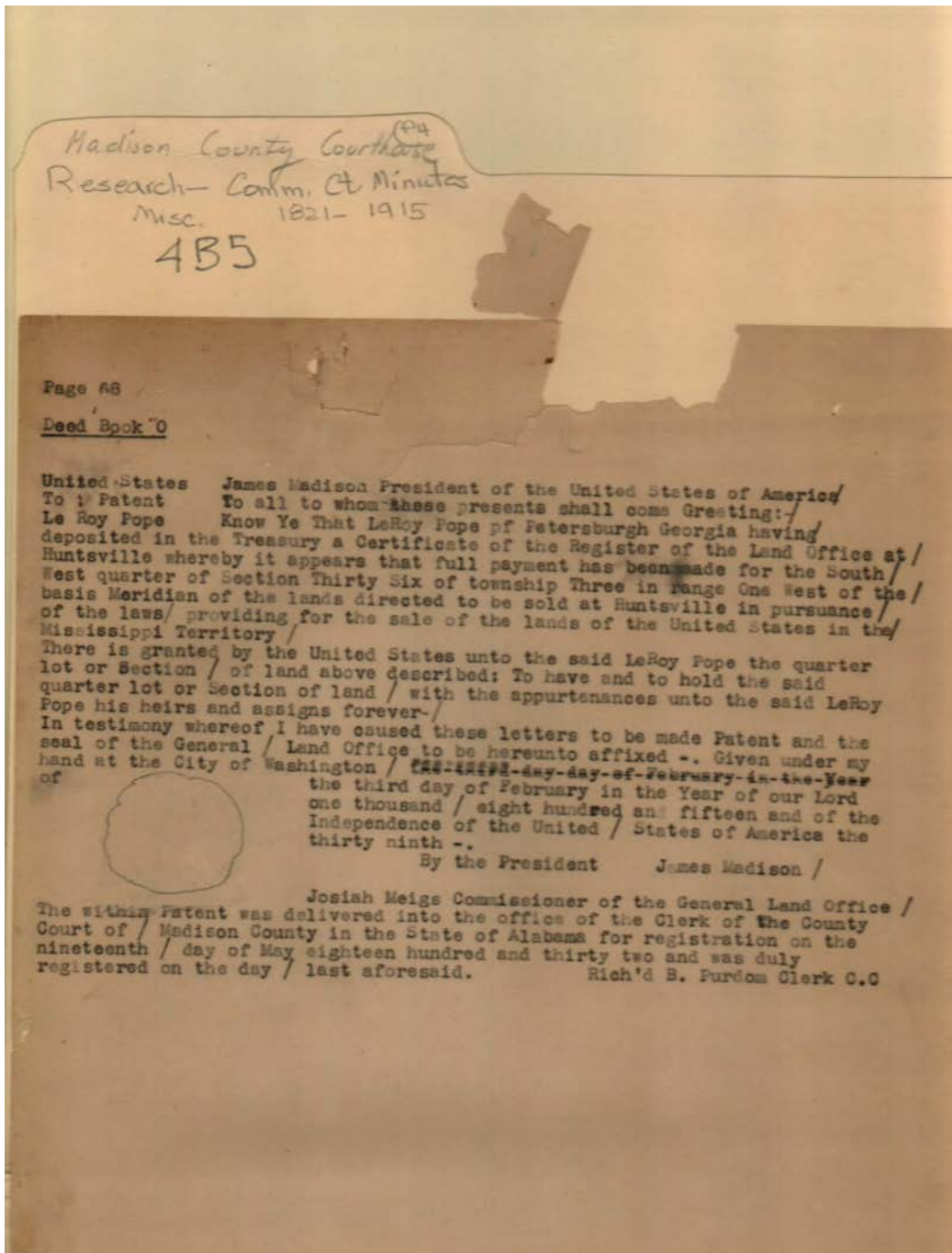
