THE FOLLOWING QUESTIONS HAVE ARISEN FROM SEVERAL SOURCES CONCERNED ABOUT THE BUILDING OF A NEW PUBLIC LIBRARY BUILDING IN HUNTSVILLE:

THE SITE SPECIFIED FOR THE BUILDING HAS BEEN SUBJECT TO DIFFERING REPORTS- IN NEWSPAPER REPORTS. IS THE SITE SOUTH OF THE MAIN TELEPHONE BUILDING THE FINAL SELECTION?

HAS ANY PRELIMINARY CONTACT OR ESTIMATE BEEN MADE TO DETERMINE IF PRESENT PROPERTY OWNERS ON THE PROPOSED SITE MIGHT SELL WITHOUT CONDEMNATION PROCEEDINGS?

WILL CONSTRUCTION OF THE LIBRARY PROCEED BEFORE WILLIAMS STREET IS ~~####~~ EXTENDED?

WILL THE CHAMBER OF COMMERCE BE GRANTED A PORTION OF THE SITE FOR THE LIBRARY? IF SO, HOW MUCH LAND WILL BE NEEDED FOR THIS PURPOSE, INCLUDING PARKING FACILITIES?

HAVE THE ARCHITECTS BEEN INSTRUCTED TO PROCEED WITH PLANS?

CAN THE LIBRARY PLANS AND CONSTRUCTION BE EXPECTED TO BE CARRIED OUT AT THE SAME TIME AS THE NEW CITY HALL, OR WILL LIBRARY PLANS BE DEFERRED PENDING CITY HALL CONSTRUCTION?

ACCORDING TO THE NEWSPAPER ANNOUNCEMENT OF DECEMBER 14, 1962, A GRANT OF \$35,000.00 PLANNING MONEY WAS MADE BY THE COMMUNITY FACILITIES ADMINISTRATION. IS THIS MONEY ACTUALLY AVAILABLE NOW OR ARE FURTHER APPLICATIONS NECESSARY?

IS THERE ANY DRAWBACK TO CONTRACTING WITH ARCHITECTS SO THAT PLANS MAY BE DRAWN? IF THEY ARE ALREADY PROCEEDING, ON WHAT BASIS COULD THEY PLAN A FACILITY OF THIS NATURE WITHOUT CONSULTING THE LIBRARY?

UNDER TERMS OF ALABAMA LAW (SPECIAL SESSION, 1961), ACT NO. 289, THE LIBRARY BUILDING AUTHORITY IS EMPOWERED WITH EVERY MEANS TO ACT TO RELIEVE A CRITICAL SITUATION IN THE CITY OF HUNTSVILLE. IT HAS NOW BEEN OVER ~~####~~ 17 MONTHS SINCE THIS ACT WAS PASSED. WHAT JUSTIFICATION CAN THE LIBRARY, ITS PERSONNEL, AND ITS SUPPORTERS GIVE TO PUBLIC INQUIRY ABOUT THE DELAY?

HOW LONG A PERIOD HAS THE ARCHITECT TO FINISH PLANS FOR THIS BUILDING? CAN THIS BE SHORTENED IF THE ARCHITECT CHOOSES TO DO SO BY MORE CONCENTRATED EFFORT?

WHAT IS THE LENGTH OF TIME NECESSARY FOR FINAL APPROVAL FROM THE PROPER AUTHORITY?

IS THERE ANY MEANS BY WHICH INTERESTED PERSONS COULD EXPEDITE ANY OF THE PLANNING AND CONSTRUCTION?

IS THERE ANY MEANS AVAILABLE TO RELIEVE THE CAPACITY LOAD NOW ON THE PRESENT FACILITIES AND WHICH SEEMS DESTINED TO CONTINUE AND INCREASE FOR MANY MONTHS PENDING THE CONSTRUCTION OF NEW QUARTERS?

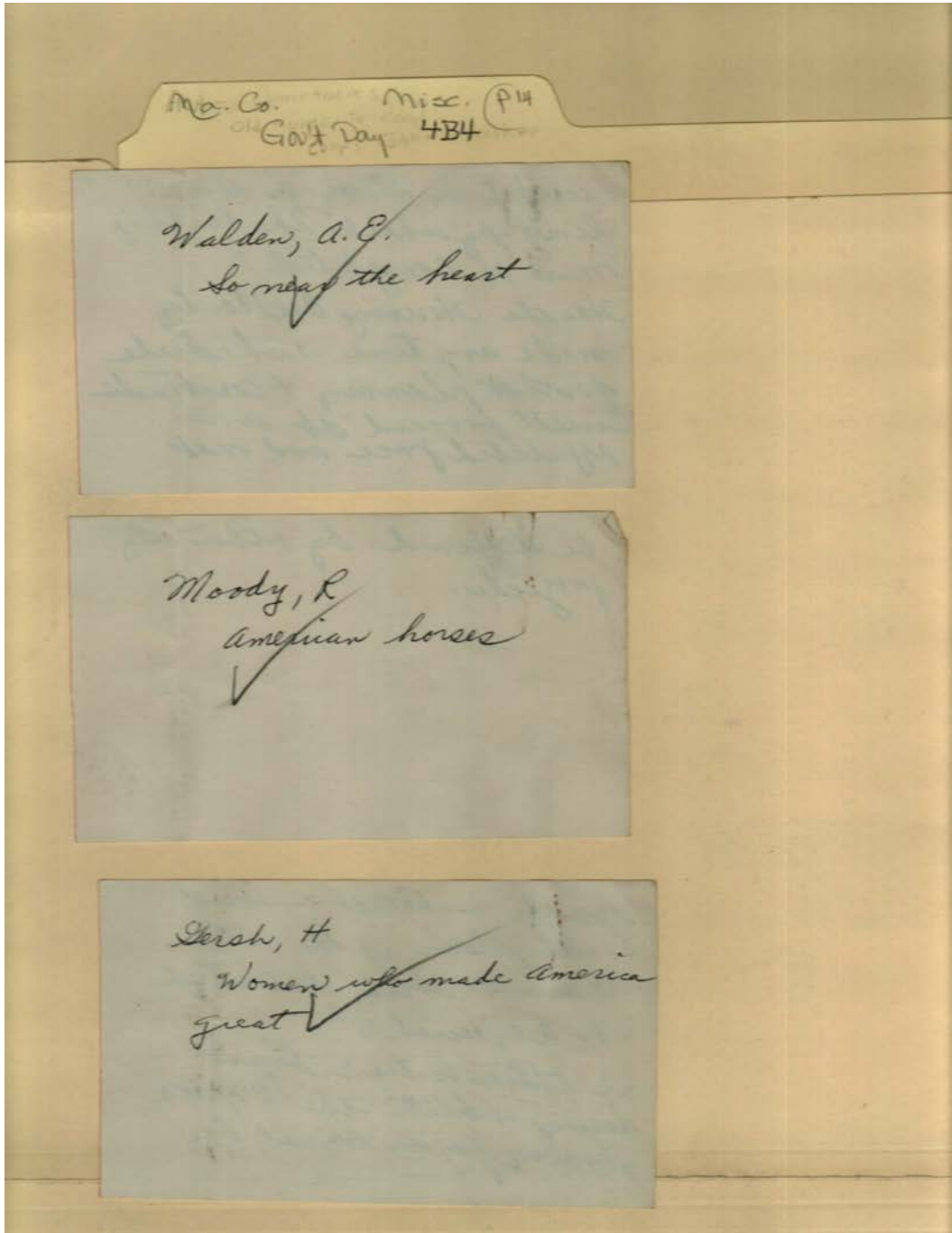

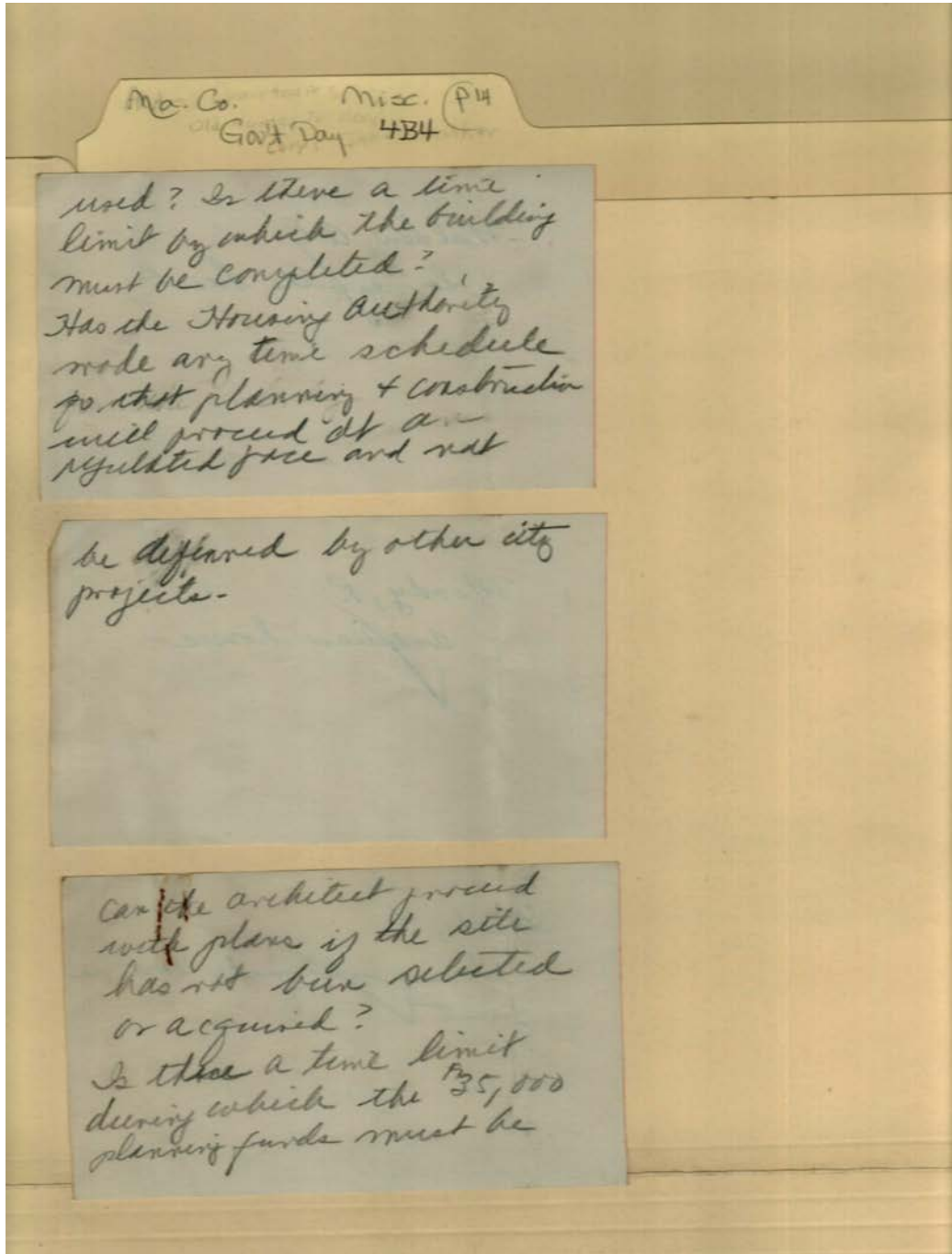
