In what instance indeed, have your honorable bodies refused to interpose in behalf of Citizens situated as are the undersigned? And are they fated to constitute the only exception? Have they alone sinned beyond the reach of mercy? Is the day of saving grace passed only as to them--and passed forever? the undersigned would fain hope not.45/ There is no report that the intruders were removed, and it is easy to believe that Jackson simply ignored orders with which he disagreed. The new administration soon took steps to put the Chickasaw lands up for sale. Perseverence Pays Off A large crowd gathered in Huntsville for the opening of the auction of land in Limestone County on 2 February 1018. Bidding was brisk for the best tracts. John Read, Register of the Land Office, Huntsville, Alabama Territory, reported that "the lands Sold will probably average higher than any lands of the United States ever did. Many tracts brought 35 to \$40 per acre & some 70 to \$78.*46/ Land that was left over after the auctions was sold at private sale for \$2.00 per acre. Most of the Sims petitioners bought \$2.00 land. Only 22 of the original 450 who signed the 1810 petition bought land in the 1818 sale. The acreage they purchased is spread across the area west of the Chickasaw line in Madison, Limestone, Lauderdale and Lawrence Counties. (Madison County's western border was changed from the diagonal Chickasaw Line to a north-south line between Ranges 2 and 3 west in Pebruary, 1818. Thus former Chickasaw land, now in the southwest corner of the county, was for sale.) A large group was concentrated at the original site of Sims Settlement on Elk River. James Sims bought 863 acres, the largest purchase made by a squatter, at \$2.25 per acre in Township 1, Range 5 West (T1,RSW).4J7 Thomas Redus, an early settler who signed next to Sims in the land sale log, bought two blocks of land in T1,RSW, and a second site farther south in T2,RSW. Benjamin Murrel, who also came with Sims in 1806 and was removed in 1809, had gone to Madison County and bought land on Limestone Creek in 1812 and appeared on the 1816 Madison County Census. Listing himself an Elk County resident in 1818, he
