
THPD - CREATION OF fa -2-4. The policy of the National Trust is first to encourage local organizations to maintain properties, and then to encourage prospective donors to give properties to National Trust approved organizations. (a) In order to encourage this practice, and to the extent feasible, financial assistance should be given these organizations, along with free advice and assistance. (b) Properties may be acquired by the National Trust with the understanding of the donor that at such a time as organizations can be found, or created, which will operate and maintain such properties, they may be turned over to such organizations for their complete management with appropriate restrictive and reversionary clauses, and subject to National Trust inspection from time to time. Objects Objects for consideration fall into the following categories: 1. Items which are of importance artistically or historically to the United States of America, and can be displayed in National Trust properties or in places approved by the National Trust where they can most benefit the public; 2. Items which are a necessary part of the visual display in National Trust properties, but which are not in themselves of extraordinary historical or artistic interest; 3. Items which are of foreign or American origin or manufacture which have special and direct relationship to some property or event significant in American history and culture or could be sold for the benefit of the National Trust. Governing Policy for Objects 1. The National Trust will not appraise or value objects for the donors. 2. The National Trust will perform only as a service agency in assisting with the exchange or donation of objects between mesones and donate. 3. The National Trust will not consider gifts that in its discretion are unreasonably restricted.





	1. The National Trust staff will make inspection of every property offered and procure documents and pertinent information related to proposed gift.
	2. The National Trust staff will prepare and submit to the Properties Committee a complete Properties Consideration report (details and evaluation), relating the property to the National Trust Criteria and the Properties Policy.
	3. Upon receiving this report the Properties Committee may:
	<ul> <li>(a) Recommend that the property go to a qualified existing organization or that such an organization be created for this purpose;</li> </ul>
	(b) Recommend to the Trustees the acceptance of the property;
	<ul> <li>(c) Reject the property, and report to the Chairman of the Board who will take such action as he deems necessary and report thereon to the Board of Trustees;</li> </ul>
	(d) Request the staff to obtain additional information from other experts (architectural historian, historian, architect, antiquarian, or others).
	<ol> <li>Communications with donors regarding acceptance or rejections will originate with the Chairman of the Board.</li> </ol>
	5. The Properties Committee will recommend acceptance and offer a plan for proposed use through the Chairman of the Board to the Trustees.

#### ARTICLE III.

#### Membership.

A. <u>Qualifications of Membership</u>. Membership in this corporation shall be open to residents of the Twickenham Historic Preservation District of the City of Huntsville, and the owners of property located therein, and members of their immediate families of voting age, who subscribe to the objects of the organization and to such Honorary Members as shall be elected by the membership of the corporation.

#### Officers.



D. <u>Qualifications of Officers.</u> Every officer must be a qualified voting member of the corporation.

E. <u>Election of Officers</u>. The officers shall be elected by the membership of the corporation at the annual meeting, at which time a single slate of officers shall be presented by the nominating committee. Voting by proxy is not permissible. Installation of the duly elected officers shall take place immediately following their election.

#### ARTICLE V.

#### Meetings.

A. A meeting of the membership shall be called annually by the President at a public meeting place on the first Tuesday night in June, or as soon thereafter as possible. At this time written reports of officers and committees shall be presented and incorporated into the minutes, election of officers shall take place, and such other business as is necessary shall be conducted.

B. Special meetings may be called by the president with the concurrence of the Board of Directors.

C. Written or printed notice of every annual and special meeting shall be given to every member of the corporation either personally or by mail not less

A quorum for any meeting shall be one-tenth of the membership. ARTICLE VI. Board of Directors. A. The Board of Directors shall consist of twelve voting members of the corporation elected by the membership of the corporation at the annual meeting to serve a term of three years, or until their respective successors shall be elected and installed; provided, however, that of the first Board of Directors elected the first four elected shall serve terms of one year each, the next four elected shall serve terms of two years each and the last four elected shall serve terms of three years each. At each subsequent annual meeting Directors shall ( be elected for full three-year terms to fill the places of those directors whose terms are expiring. Directors can succeed themselves. B. The Board of Directors shall have the authority and duty to establish all policies governing the administration of the affairs of the corporation. C. D. The officers of the corporation shall be ex officio members of the Board of Directors and entitled to vote as other members of the Board. E. Notice of meetings may be given to the members of the Board of Directors verbally, in person or by telephone, or in writing, either personally delivered or mailed to the last address of such member shown upon the records of the corporation and, if mailed, shall be deemed given twenty-four hours after deposited in the United States mails, so addressed and bearing sufficient first-class postage.

ARTICLE VIL.

Committees.

A. Standing Committees.

1. A legislative committee, composed of such number of members of the corporation as the President shall appoint annually, shall examine all local, state, and federal legislation which might pertain to the interests of or affect the Twickenham Historic Preservation District in any way. It shall notify the Board of Directors of such impending legislation, with recommendations for action by the Board in relation thereto. This committee may from time to time initiate the study of needed legislation, and submit written recommendations to the Board of Directors for action relating thereto. The Chairman of the Legislative Committee shall be an attorney at law and shall, upon request, attend meetings of the Board of Directors and advise them and the officers of the corporation upon legal questions of concern to the corporation.

2. A nominating committee, composed of such number of members of the corporation as the President shall appoint annually, shall nominate a single slate of officers and directors to be elected at each annual meeting of the membership of the corporation. Prior consent of each person nominated shall be secured by the Nominating Committee.
