TO: Mayor Joe W. Davis
Members of the City Council
of the City of Huntsville

The undersigned hereby respectfully requests, in writing that the governing body of the City of Huntsville proceed under and by virtue of Act No. 1307, H. 2095, of the 1971 Regular Session of the Legislature, to designate an historic preservation district in the area heretofore generally known and referred to as The Twickenham District and the undersigned further respectfully petitions the governing body to take the following actions or steps in causing said area to be designated an historic preservation district as follows:

1. Adopt an historic preservation ordinance creating and establishing an historic preservation commission pursuant to said act.
2. Pursuant to said act make a determination of the boundaries of the proposed district to include an area to be determined by the governing body to possess historic significance as to give such district as a whole a character of historic significance worthy of preservation in accordance with Section 2 of said act.
3. That all appropriate resolutions and ordinances leading to the creation of an historic preservation district and to the designation of the area commonly known as The Twickenham District as an historic preservation district be introduced and adopted by the Council.
4. That the name of the area be designated "Twickenham Historic District."

The undersigned hereby request that the property hereinafter described be included within the proposed historic preservation district.

A legal description of the property owned by the undersigned is attached hereto and made a part hereof marked Exhibit 1. This instrument has been executed by the person or persons having the lawful right and authority to execute the same, either as owners, or for and on behalf of the owners. II. Information to be Submitted for the Commissions' Review

The application can be assessed properly for a Certificate of Appropriateness when it contains the following information.

A. For New Construction, Major Renovation, or Major Repairs and Additions:

1. **Photographs** showing the building front, adjacent buildings, and all affected sides of the building.
2. One copy of **scaled drawings** showing all revised exterior wall elevation views and plans, materials, and details.
3. **Paint color samples** of all proposed colors and their locations.
4. **Scaled site plan** is applicable, showing proposed fences, walks, drives, buildings, etc., with details or photos of any fence or wall types and sizes proposed. Adjacent structures should be shown if any are within approximately twelve feet from the property lines.

NOTE: The Commission suggests that preliminary design sketches be submitted for review before extensive design work has been done to eliminate the possibility that the extensive finished design work might have to be revised or redone to meet the criteria for the issuance of a Certificate of Appropriateness.

B. For Minor Renovations, Alterations or Repairs:

1. **Photographs** showing the building front and all sides, and areas affected by the proposed work.
2. **Drawings** or written description of the proposed work, to include materials, details and colors as they relate to the existing structure.
3. **Site plan** and building location plan, if needed, to assess the appropriateness of the proposed work.
4. **Adjacent structures** on the premises should be shown if applicable.

C. For Signs:

1. **Scaled drawing** showing colors, letter style, supports, location and lighting, as applicable.
