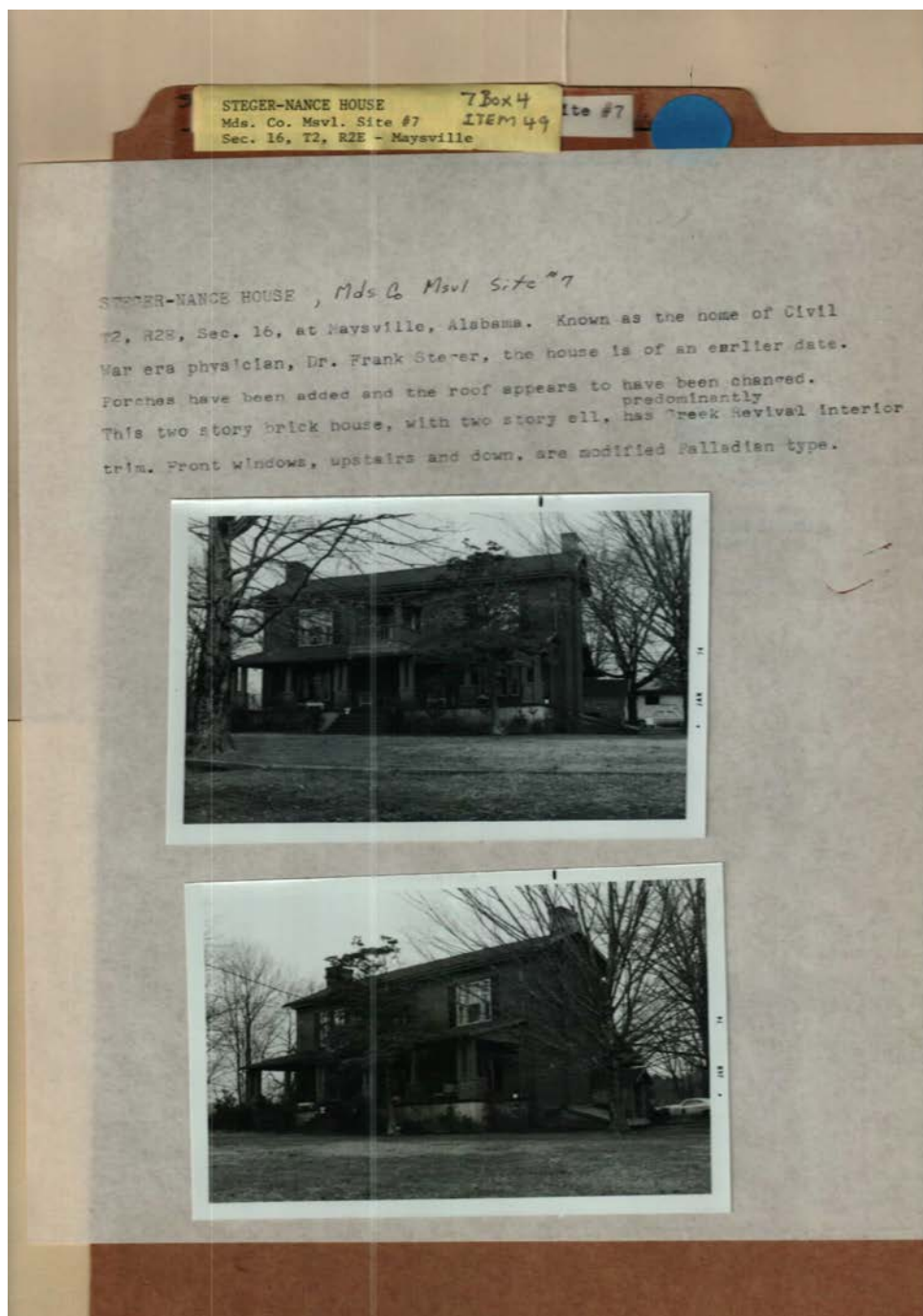

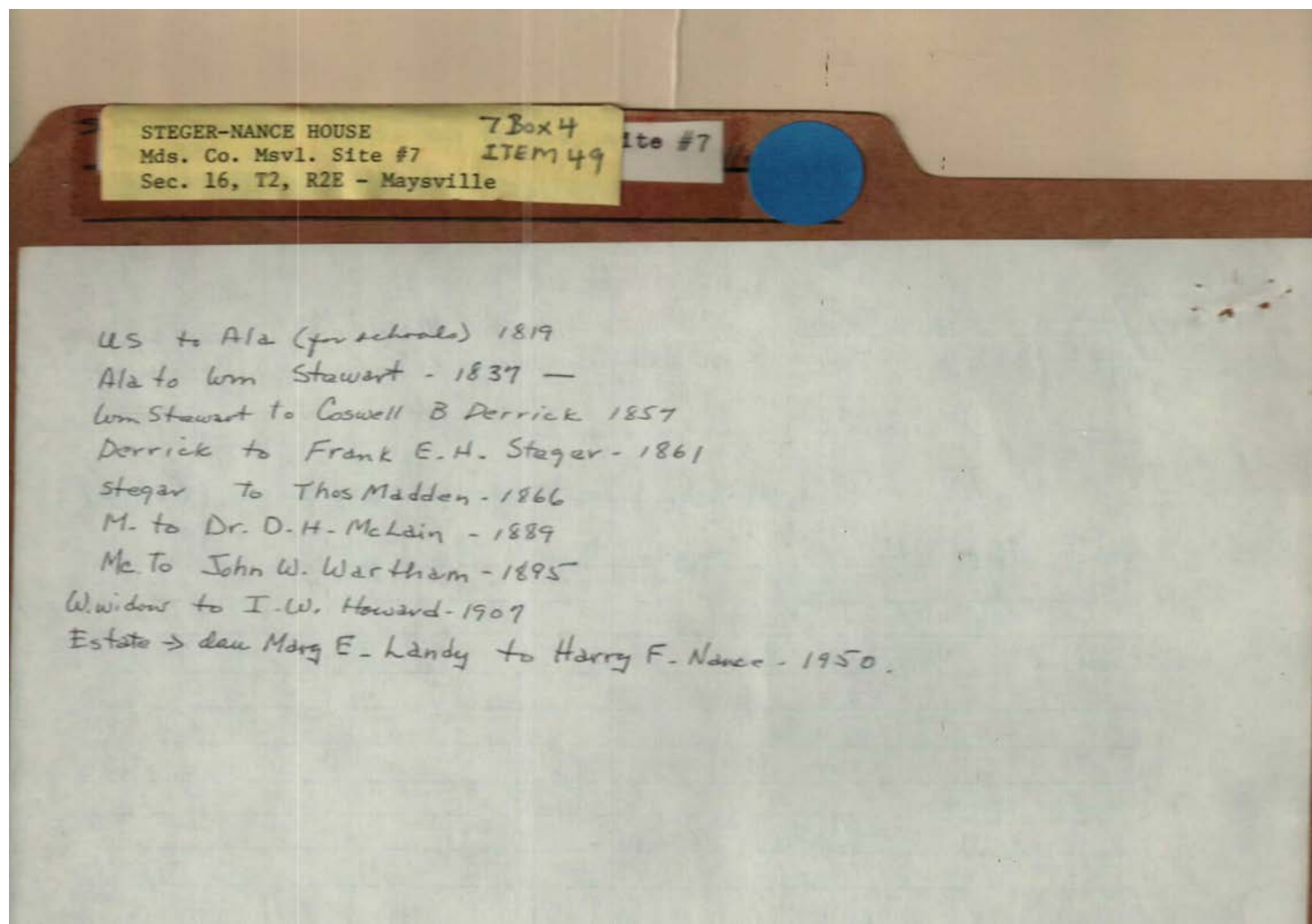

11. Architectural Description: 2 story brick. Originally 3 rms downstairs + 3 up. Stairs to upstairs originally only in front room only goes to that room - 14" solid walls - cedar woodwork, square nails throughout original part. Porch, kitchen, halls + kitchen added. Front stairs go to the two front rooms - almost certainly two rooms and chimneys; gabled roof - front windows multi-paned Palladian. 9 over 9 center pattern; 3 over 2 in front doors; back windows 6 over 9 pane. "Dr. Steger place" - office, kitchen, and porch standing. Dr. Howard - brick pattern. Nance, Harry - 1950 another chimney space at rear - 2 cedar lintels - hand-hewn iron Sties brick outbuilding original altered roof over hang? strangely plain wooden mantel - Gk Rev?

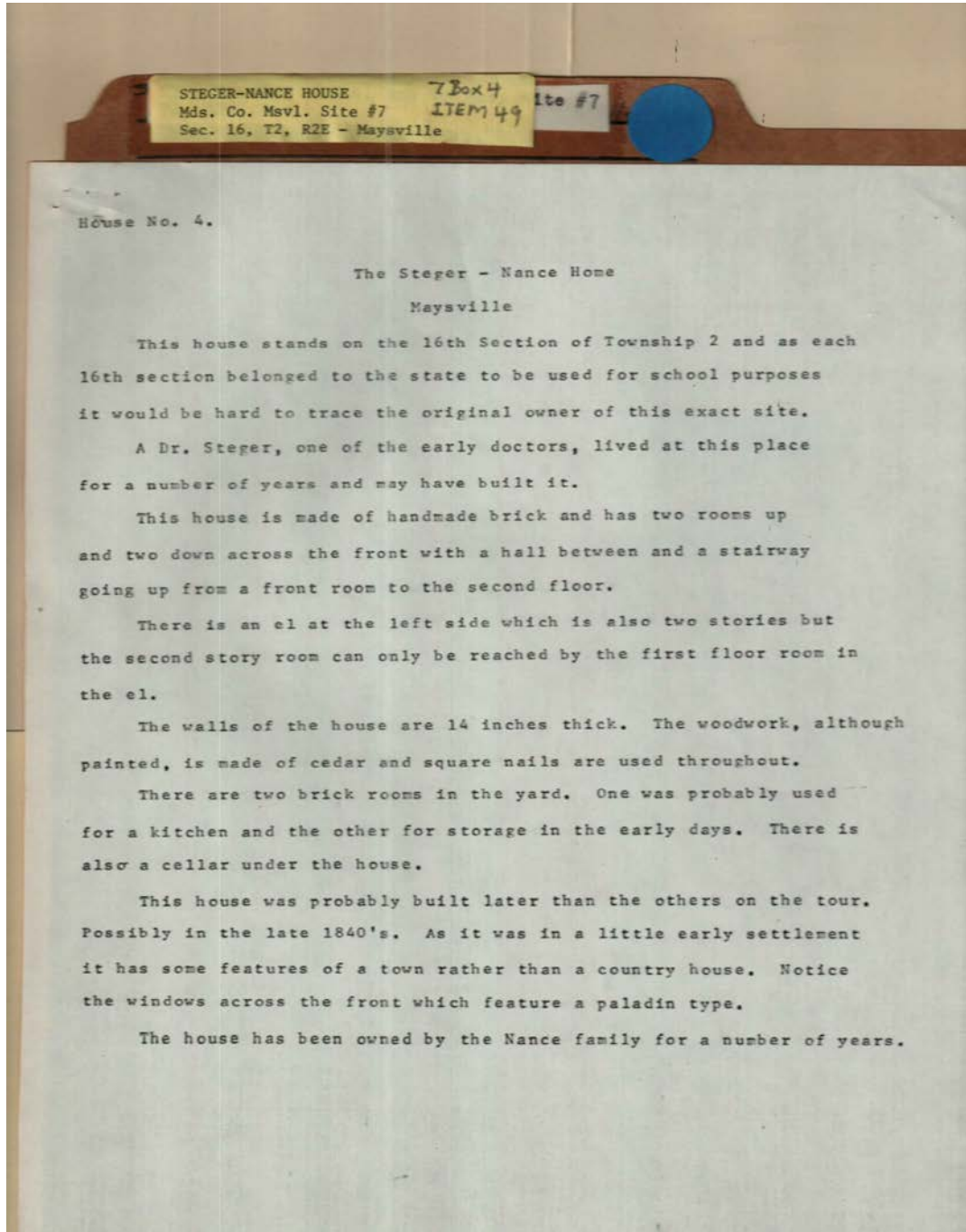



14" solid walls cedar woodwork, square nails. Front stairs to 2 upstairs rooms.
Originally only stairs to ^{rear} upstairs room were in back room downstairs.
Porch, kitchen, halls, baths added later
Original brick office and kitchen standing.
Two interior and chimneys in gabled roof. Front windows mediterr. Palladian.
9 over 9 center parting  These windows upstairs over two and
entrance on ground floor. Back windows 6 over 9 panes.
Cedar lintels. Land forged iron 5- bar ^{strong}
altered very much? Reddy plain wooden and Rivet metal.
