 tion, but the stock will be accumulating and may continue at the season
 beyond the compass of the means of operating. The ruinous rates of Discount at
 Exchange, will prevent it readily to Cotton. If we have not better news from
 abroad by next steamer (expected in three days) think I shall let go at whatever
 I can get.
