reached, this evening, and the bill will be delivered  
to Morrow, in time. You must have got up  
in good time. I sent the box & letters out  
on yesterday by Jim Bailey, to your Father.  
To day he sent his servant in Miss Weakley  
sent him a good large piece of bread, which  
I hope he will enjoy. Soon as Court adjourns  
I will go out to see him.

No letter from the House this evening  
& I hear of no articles being sent up. I fear  
James must be sick, or very busy.

Nothing has occurred since you left of any  
interest. I hope Farnack will go up and  
arrange all things right. If you have any  
news write to me

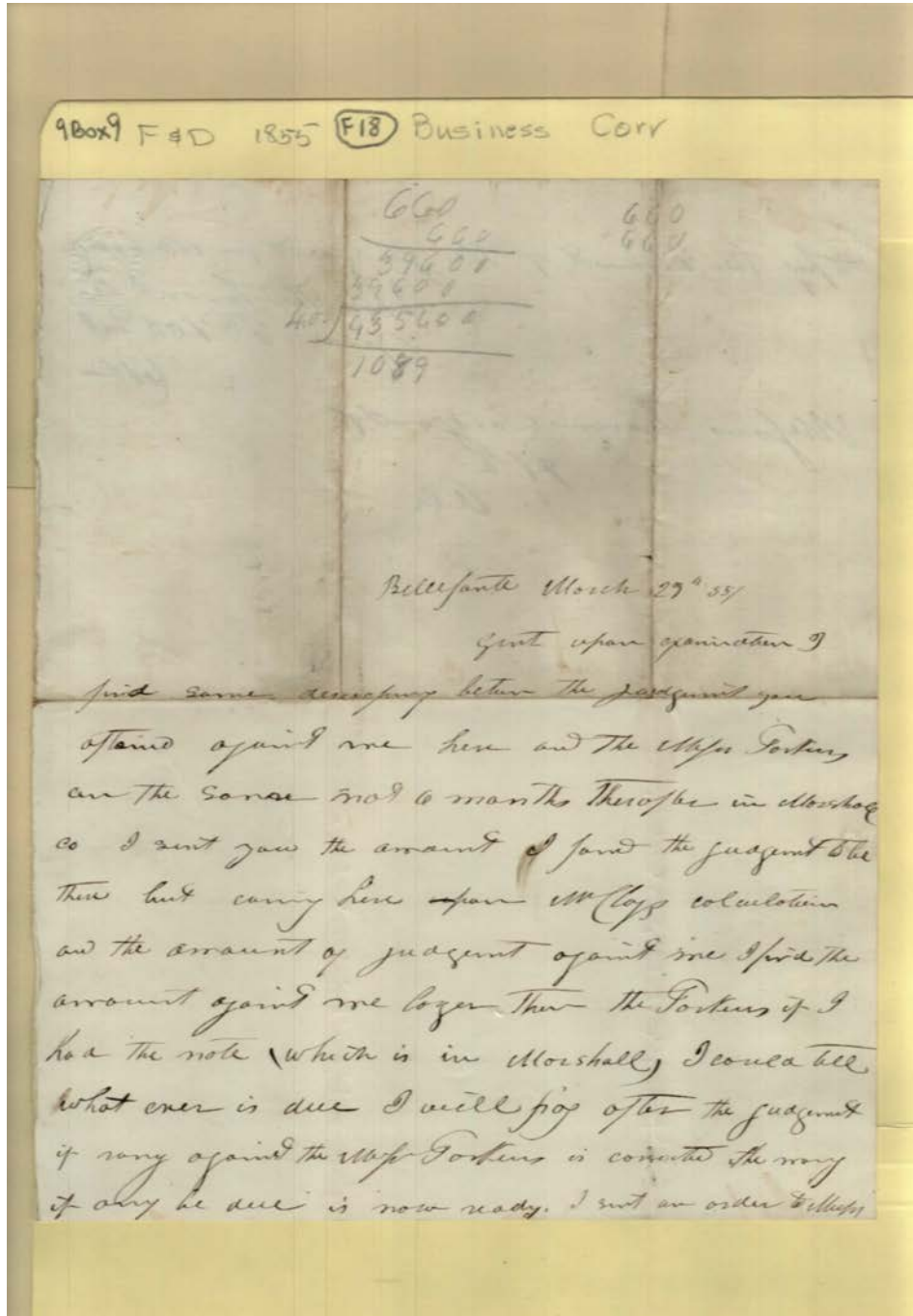

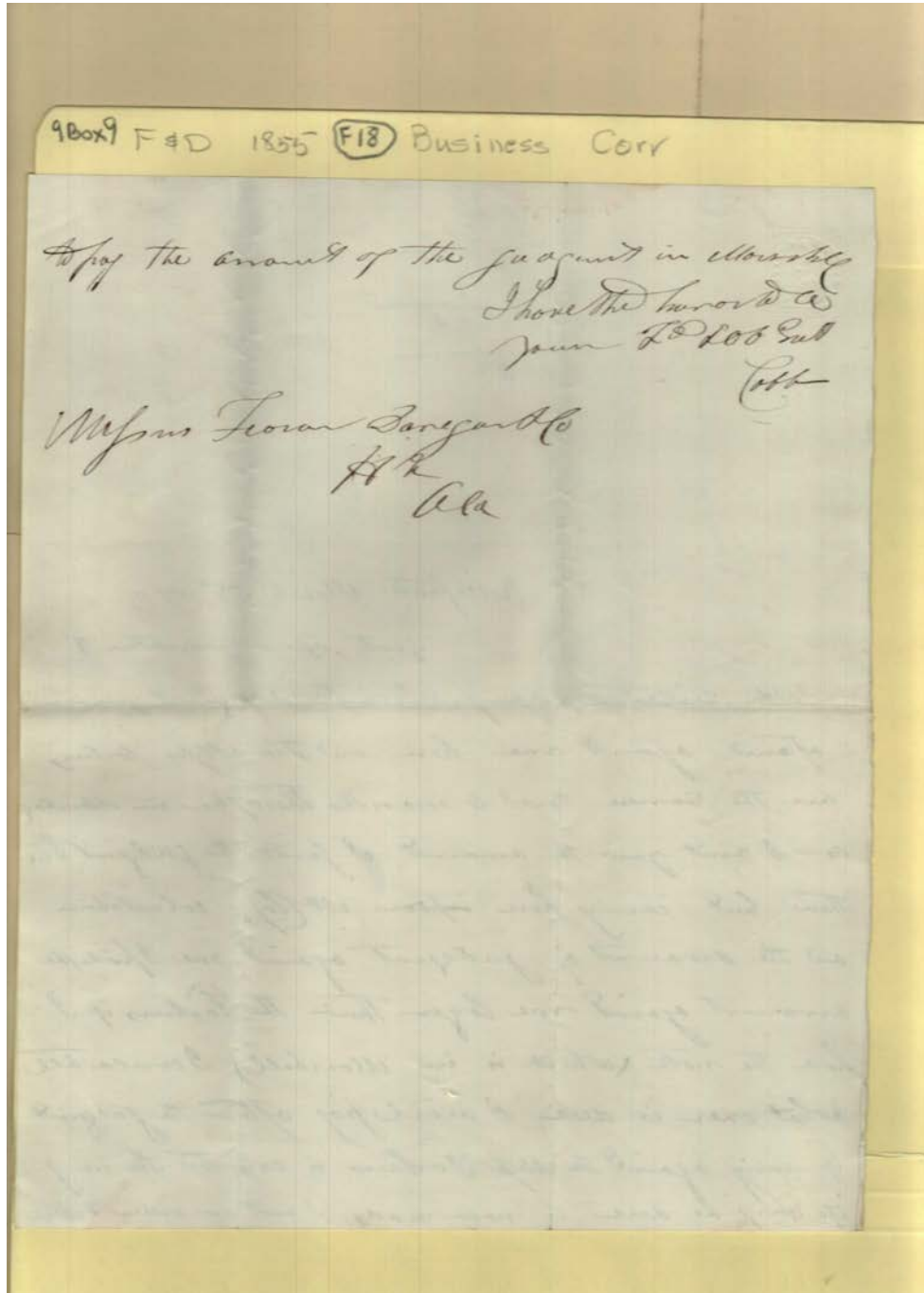
