bale of what we are certain it will ship  
and we think probable we shall ship 275 bales  
from here. (we include our former drafts & advan-  
ces when we say drawn for less than \$25 on the bale  
and something upward of 30 bales from Calhounville  
We should not draw on you now or until  
we had started the Cotton but our stock of  
goods is getting low and the writer wants  
to start east to replenish next Monday

We wrote a few days since, to your house in New Orleans, to place to our credit the proceeds of C.O. Harris 38 Bales 90<sup>th</sup> <sup>700</sup>/<sub>100</sub> Dollars, we gave Messrs Pepper & Davison an order on you for 355 <sup>700</sup>/<sub>100</sub> Dollars if not already paid you will please pay when presented
