 they are my neighbors and good as "old wheat." The last
 two I had promised last week to accept - at which time the weather
 was as hot as I ever felt it and the Cotton Crop moving bravely
 ahead, but the day I left Memphis it commenced raining and
 continued two days - yesterday morning it cleared off with a cold
 north wind which is yet prevailing and if the night and three
 hours longer we should have frost. Yesterday in going over a large
 part of my own Cotton I found the rust making sad havoc of
 and apprehend it may become general. The crops in this section
 of Country have grown rapidly the last three weeks - the plant
 is now quite as large as this period last season, blooming, bolls
 beginning to swell, but the stalks are tender and watery rendering it
 liable to rust and other diseases. With moderating dry
 clear weather the crop would be large - but if it continued
 wet & cold, it would be cut down to a mere nothing. The
 Crisis is present - the result most important and admonishing
 is that we should suspend further undertakings, to pay money
 until it is pretty well ascertained. I shall stand off for the near
 two or three weeks, unless it be for very small sums in such cases
 as I cannot refuse, and then act according to circumstances.
 I hope you will approve my determination and act in the same
 manner, and prudently examine. My son tells me he has not had
 an rain during the season that was not succeeded by cold
 weather for several days. Such seasons I have known before
 but never know such a year to give a good crop.

I am anxious to hear from the crop in your State, North Carolina:
 please let me hear from you the result of your observations
 and any information you may have from other sections of the
 Cotton region. I go to Raleigh to my County Election the day
 after tomorrow - and shall attend the County Court of Jones the
 next Monday.
