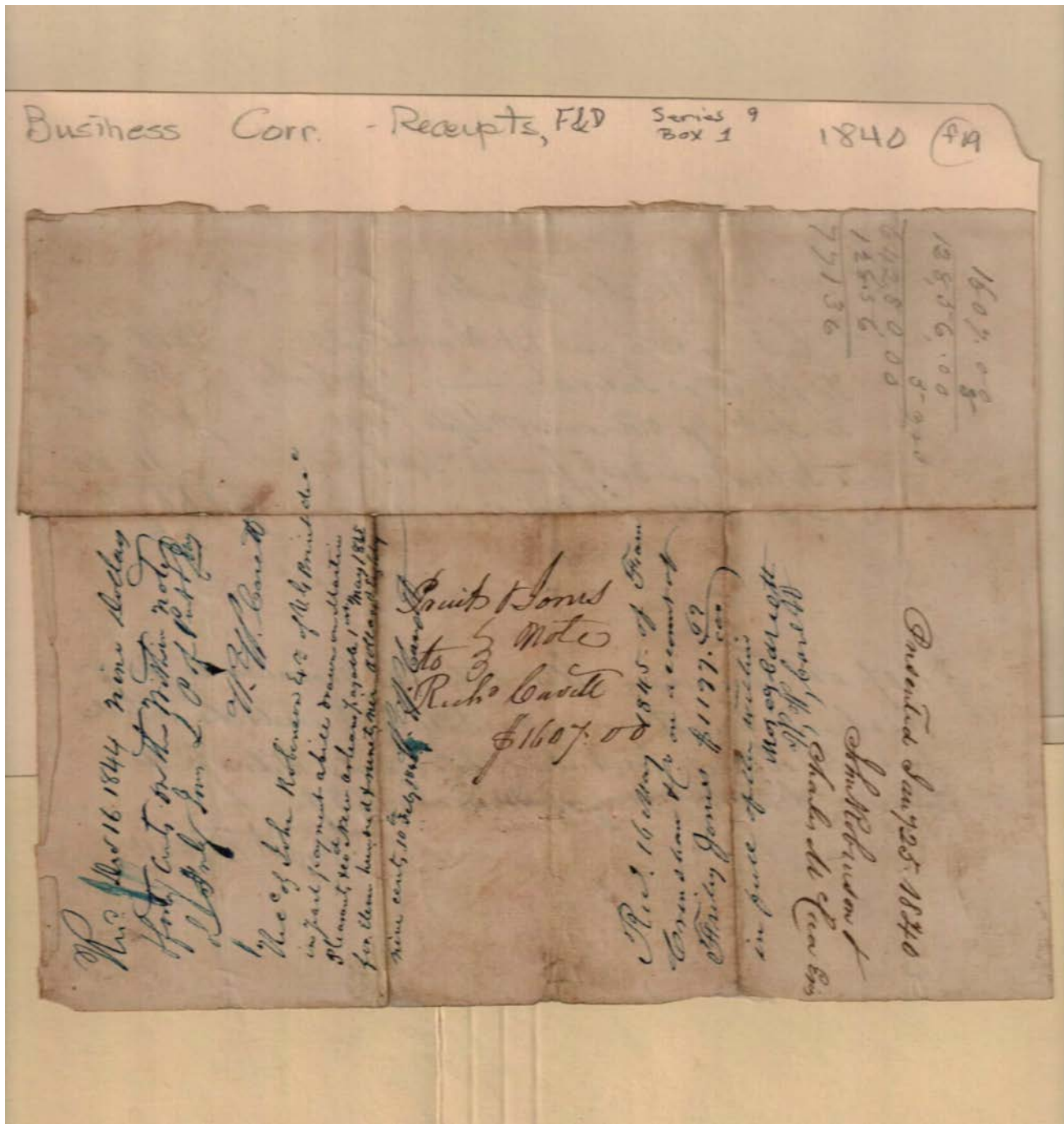

Dear Sir

Young to our Mr. Erwin of the 1<sup>st</sup> March was rec<sup>d</sup> by us - Mr. Erwin himself knows nothing of the business referred to, nor Mr. Watson much - Mr. Noble had little to say to us in relation to the sale of the land and Mr. Armistead & ourselves are not particularly friendly we dislike to intermeddle officiously, as he is much to mean a man for one to trouble himself about. The best reply we can give you will be a statement from the Books of the conveyance of the land & their dates - By ascertaining the date & situation of your judgment you may then be enabled to form an opinion yourself.

Kinward Bennett sold 237<sup>1/2</sup> acres to W<sup>o</sup>. A. Bass the deed bears date 27 Aug. 1835 & was recorded the 7 March 1836

Hugh Torbet sold to W<sup>o</sup>. A. Bass 2 half quarter sections deed dated 27 Aug. 1835 & recorded 7 March 1836.

Robert Armistead became security on the notes given for the land -

W<sup>o</sup>. A. Bass made a deed to James Semple to secure Armistead, dated 24. July 1836 and recorded 12 Mar. 1836
