All of the said property hereby mortgaged and now on hand is more fully described in an inventory thereof hereto attached marked A. This mortgage is made to secure said debt and if the same is paid as the notes described become due, then it is to be void and of no effect - but if we fail to pay any one of said notes when it is due. then the Huntsville Gas Light Company by its agents, is authorized to take possession of said property and after advertising the same for ten days by a notice in a newspaper published in Huntsville, to sell the same for cash to pay said debt. It is agreed that if we fail to pay any one of said notes for thirty days after it is due,
