You will be better able to evaluate and understand this letter if I start by telling you that I was the Ordnance Officer of the 8th Infantry Division for slightly more than two years, 1943-1945, which period included all of its overseas and combat experience in World War II. During this period Colonel Nickerson was in command of the 56th Field Artillery which was a unit of the division. The answers to your questions follow: a. Testimony as to his character, devotion to duty and interest in the military service. b. I do not know what detail this testimony will take, but think it will be based on experience during World War II and occasional contacts since. c. When I read about this court-martial I wrote Colonel Nickerson offering to be a character witness for him. He accepted by letter. That is all the

- communication we have had about it.
- d. I know of no other testimony that is expected of me.
- e. (1) First knew him in 1943.
  - (2) I was Ordhance Officer of the 8th Infantry Division from the summer of 1943 until after the Division was returned from Europe. Colonel Nickerson commanded the 56th Field Artillery of the 8th Infantry Division. Our wives were good friends but not particularly intimate. We have had about four meetings since the war, usually for a meal and a social evening.
