all that lot or parcel of ground con-  
-taining one acre and a half ~~of ground~~  
more or less lying and being in the  
Town of Hazelgreen known as the  
gin lot bounded on the north by a  
part of the lot known as the French  
lot on the West and South by Parkes  
Lowland land and on the East by  
G S Davy lot. The said lot or parcel


